PUBLIC HEARING ON DOWN TO EARTH

A public hearing was scheduled to allow Mr. Greenstein to present the Board of Commissioners with a plan for refuse pickup. Mr. Greenstein did not show.

PUBLIC HEARING ON CITIZEN PARTICIPATION GROUP MEETING

Lori L. Osborn, Borough Administrator, outlined the meeting held by the Citizen Participation Group on what type of project should be submitted for a Community Development Block Grant.

The group was in favor of a project which would include ADA requirements for the Borough park. The project would include repaying of the parking lot and putting in two handicapped parking spaces. The park will also have a wheelchair accessible path/fitness trail around the park. Picnic tables will be added, some of which will be wheelchair accessible. A floating dock would be positioned on the lakeside for canoes and kayaks. It was suggested that the basketball court be repayed. There was some discussion about adding some ADA accessible playground equipment and adding items on the fitness trail that would be ADA accessible.

Ms. Osborn continued, stating the group looked at the small grassed area adjacent to the park and had an idea to either rent space for a Farmer's market or to have some kind of a community garden where the Borough could rent out plots for flowers and vegetables.

There was also a suggestion to try to get the dead trees removed from the lake.

The Borough Engineer will put a plan together, including a cost estimate and present it to the Borough.

Pat McGinnis asked if the Borough would need a lifeguard at the dock and Ms. Osborn answered no. It will not be used for swimming; only for canoes and kayaks.

Frieda Shalam asked if the Board would consider doing something that could make money for the town.

Mayor McLaughlin stated he was thinking of maybe renting space to a company who would in turn rent kayaks and canoes. There is a possibility of doing some sort of revenue making venture.

There was some discussion on moving a tennis court to the grassy area and Mayor McLaughlin suggested putting something in the newsletter asking residents for their opinion on the tennis courts. He stated the Borough should also put in something regarding the water tower.

Comm. McLoughlin suggested putting the plan on the website.

GENERAL PUBLIC HEARING

Mrs. Shalam asked where the new cell tower would be located and Mayor McLaughlin responded that it would be close to the same spot. The water tower is in disrepair and they have been informed that it should come down. It would cost them upwards of \$200,000 to fix it. The cell companies are offering to put up a monopole.

Comm. McLoughlin asked about the request the Borough received for a groundwater monitoring well. There was some discussion on whether there were contamination issues and why the well had to be placed across the street. The Borough Administrator was instructed to get more information. Comm. McLoughlin asked that they be invited to the next meeting.

There was a discussion on replacing a pair of prescription sunglasses that were lost during the boardwalk fire. The cost was \$808.95. Comm. McLoughlin stated he did not want this to be precedence setting. Comm. Bolan asked if there was a police report. The Board asked the Administrator to get more details.

There was a short discussion on the well points with the Army Corps of Engineers. Comm. Bolan stated the plan is to hook the temporary system into the Borough's pumps and run that through the summer.

Mrs. Shalam stated she is representing her son, Maurice, who could not be here as he is taking his finals. He is requesting to remain in his same spot on the cabana list. This year the rule was that you had to have your own address to remain on the cabana list. Wimpfheimer and Reddy were given until May 8th to show proof of residency. Maurice obtained his residency before May 8th. It was not fair that he be moved to the bottom of the cabana list.

Comm. Bolan stated the May 8th deadline was for members who already had cabanas this season. Maurice did not become eligible to be on the list until this year.

Mrs. Shalam stated that prior to these rules, you only had to be a resident to be on the list.

Comm. McLoughlin stated that someone who has been on the list for many years and is behind Maurice would not get a cabana before someone who just became a homeowner.

Mrs. Shalam stated the fact that this Board creates rules out of nowhere is ludicrous. She would like the rules to show her attorney. The list could change. People could move or circumstances could change.

Comm. McLoughlin stated that is why anyone can come before the Board of Commissioners. Maurice is one of the few people they kept on the list because he became a taxpaying resident.

Mayor McLaughlin stated the Beach Club rules were passed in a public meeting and was also a part of the public record. They made these rules to try to have some uniformity. They are not singling anyone out. They always said anyone could come and talk to them. They passed the rules, one of which is a very minimal requirement that you have to be a resident of the State of New Jersey.

Mrs. Shalam stated her children were born in Allenhurst. They were not given a chance to buy a house and remain on the list. Nobody was notified.

Comm. Bolan stated the Commissioners have been going through the list for over a year now. One of the first rules was that you had to be a tax paying resident. They took fifteen kids off the list. He told Mrs. Shalam that if she wanted to file a lawsuit, she should request documents through an OPRA request.

Comm. McLoughlin stated that if Maurice had bought a house in 2013, he would have been put on the list as of 2013.

Mrs. Shalam asked if she could show proof that Maurice was part of an LLC in 2012, would that make a difference.

Comm. McLoughlin stated then they would put him on the list as of that date, provided he was over 18 years of age.

Mayor McLaughlin asked Mrs. Shalam to bring in whatever she had. They will take a look at it at the next meeting.

Mrs. Shalam stated people should have been called or e-mailed prior to being taken off the list instead of just doing it.

Mrs. Shalam asked about the house on Elberon Avenue that was approved by the Planning Board letting them put a pool in the front yard. People were not supposed to be able to see the pool.

Comm. McLoughlin stated he walked by it and he couldn't see the pool.

Mrs. Shalam asked who in the Zoning department checks to see that things are being done correctly.

Mayor McLaughlin stated they have a Zoning Officer who does go around.

There was a discussion on how the Borough makes sure the plans are followed. Comm. McLoughlin suggested requiring applicants to file digital plans.

Mr. Moriarty asked if there was any significance to one spouse being a principal as opposed to both. Comm. McLoughlin stated they treat spouses as principals.

Donna Clause stated that someone at the last meeting asked about testing the sand. Mayor McLaughlin stated they asked the DEP and were told that the sand particles were small enough that testing was not required. Contaminates cannot stick to it. He stated they have asked the Engineer to test the sand also.

Mrs. Shalam asked about access on Allen Avenue and Mayor McLaughlin stated the Borough received a grant for work on Allen Avenue. It will not be done until the fall.

Mrs. Shalam asked about people using Deal beach and Comm. McLoughlin stated only members will be allowed to use the bathroom.

Mrs. Shalam asked if the Commissioners considered putting a bathroom in the middle of the beach. She would be willing to raise money for that.

Comm. McLoughlin stated it was not a bad idea, especially if they put more cabanas on the beach.

There was a short discussion on parking for the restaurant in which Mayor McLaughlin stated they could give them the spots on Ocean Place after the Club closes. Comm. Bolan suggested they come in and tell them what they need and what the valet company requires.

It was suggested that there be written instructions for Sonny. Number one is do not park right on the boardwalk. Also do not walk around the Beach Club.

The Board directed the Administrator to have a sign placed at the concrete ramp saying Danger/No Pedestrians.

Comm. McLoughlin stated a special should be assigned to the Club for the next couple of weekends.

The Wimpfheimer cabana was discussed and Comm. Bolan asked the Beach Club Managers to make sure nothing is in it. Comm. McLoughlin directed that it be given away.

Mayor McLaughlin commented that the portable cabanas need new awnings.

Pat McGinnis talked about the new lights at the Beach Club. They used to be very high and really bright, but they were turned off after the pool was cleaned. Now they are lower, but have four LED lights that are on all night long. She has boards in her windows to keep the light out. She mentioned it to Steve who told her they were pointed down, but they are only angled. If you want to sit on the porch at night, you need sunglasses.

Comm. McLoughlin stated he will walk down after the meeting to take a look. Mayor McLaughlin asked why they are on all night and Marc Heitmueller, Beach Manager, stated they are on a timer and do go off at some point. They are kept on for security reasons.

Comm. Bolan asked if the lights could be turned off on the north side. Comm. McLoughlin suggested motion sensors.

Mayor McLaughlin stated they only want to charge double guest passes on the actual holidays, not the full weekend. There was some discussion about crediting those members who used two passes this past Friday, Saturday and Sunday.

Mayor McLaughlin stated the awnings on the restaurant should not block the ocean view.

Mayor McLaughlin asked that Mr. Tomaino be reminded that the lights on the east deck of the restaurant have to be moved.

There being no further comments or any further business, Comm. McLoughlin moved, seconded by Comm. Bolan, that the meeting be adjourned at 8:42 PM. Motion carried.
