PROCLAMATION

WHEREAS, Fibrodysplasia Ossificans Progressiva (FOP) is a rare genetic condition in which the body makes additional bone where bone should not form, such as within muscle, tendons, ligaments and other connective tissues. Symptoms of FOP include excruciating pain and distortion of the existing skeletal frame; and,

WHEREAS, Researchers at the University of Pennsylvania School of Medicine announced the discovery of the FOP gene in 2006 and are dedicated to FOP research; and,

WHEREAS, The symptoms of FOP usually begin in childhood, depriving children of normal development; and,

WHEREAS, There is a need for greater awareness of this disorder, its symptoms and the obstacles faced by persons and families affected by this disorder;

A RESOLUTION TO CALL FOR THE MONTMOUTH COUNTY TAX BOARD TO SUSPEND THE MANDATORY ASSESSMENT DEMONSTRATION PILOT PROGRAM

WHEREAS, In March 2013, Governor Christie signed into law P.L. 2013, Chapter 15 known as the Assessment Demonstration Pilot Program; and,

WHEREAS, Monmouth County elected to participate in this pilot program, and remains

the only County to do so; and,

WHEREAS, The Borough of Allenhurst was ordered by the Monmouth County Board of Taxation to implement the Assessment Demonstration Program; and,

WHEREAS, The program requires the Tax Assessor to annually perform a town-0wide reassessment and mandates that 20% of the properties within a municipality be inspected annually so that 100% of all properties are inspected every five years; and,

WHEREAS, The Board of Commissioners has been vocal in opposition to the program, expressing that it did not fairly and accurately reflect market value, that it inappropriately interfered with local tax assessors and that it had a disproportionate adverse effect on residential and senior citizen property taxpayers; and,

WHEREAS, Pursuant to the order, the new revised assessments were certified by the County Tax Board for the 2015 tax year; and,

WHEREAS, Residents have reported significant fluctuations in their 2015 tax assessments as a result of this pilot program, and must make up the difference owed in only six months; and,

WHEREAS, The Asbury Park Press publishes an article dated October 14, 2015, railing numerous questions about the program; and,

WHEREAS, The Board of Commissioners believes that a call for the suspension of the Monmouth County Tax Assessment Demonstration Pilot program s in the best interest of the taxpayers of Allenhurst;

NOW, THEREFORE, BE IT RESOLVED, That the Board of commissioners of the Borough of Allenhurst formally call for the suspension of the Monmouth County Tax Assessment Demonstration Pilot program; and,

OTHER ITEMS

Mayor McLaughlin stated there is a house on Norwood that was putting up storm shades. He spoke to the Zoning Officer about it and Mr. Rogers told him it was a construction requirement on new houses to have either hurricane proof windows or to put shades on those windows during hurricane season.

Ms. Osborn, Borough Administrator, stated she spoke to the Planning Board Attorney. He told her that they are in violation of the Historic Preservation Ordinance and should be given a violation. Ms. Osborn stated that she had planned to speak to the Construction Official to find out what the requirement is and then she will speak to the Borough Attorney. She will let the Board know her findings.

The Board discussed various punch list items for the restaurant building. Comm. Bolan stated he wanted to add that the bottom of the stairs needs either a motion light or light switch. Also the light in the lobby cannot be dimmed either. It may be tied into the emergency lights also. He talked about replacing the canopy above the door with an awning which would go down the stairs to create a tunnel effect.

Mayor McLaughin asked the Administrator to get in touch with John Reng regarding business signs to be placed on Ocean Avenue on both the north and south-bound sides. They also want a sign at Borough Hall pointing to the business district.

Mayor McLaughlin asked that the camera at the cabanas be made functional.

Trish McLoughlin from Allenhurst First Aid spoke about the need for a lift for the new rescue truck. It is something that is going to be mandatory on new purchases, but after seeing how it could help the members, they would like to purchase one now. The cost is \$21,000, which can be paid with an interest-free loan over five years.

The Commissioners agreed to the purchase and Comm. Bolan asked the First Aid Squad to talk to Interlaken and Loch Arbour regarding the necessity for this purchase. The Borough will also send letters asking them to place it in their budgets.

There was a short discussion on projects at the Beach Club and Ms. Osborn stated she is scheduling a meeting with the Borough Engineer. The Commissioners asked that Mr. Caron, Public Works Superintendent, be present at the next meeting to discuss the projects.

PUBLIC HEARING

Robert Scally stated it was nice to see the First Aid Squad there. They do a good job. A lot of them are families of former residents. He stated New Jersey Transit it putting in new rail crossings which are nice and smooth. He asked if the Borough could get one.

Mayor McLaughlin stated he did not notice that the crossing in Allenhurst was not smooth. He stated it couldn't hurt to ask.

At this point, Comm. Bolan left the meeting.

Tim Moriarty asked why the wall around the Beach Club wasn't solid. Comm. McLoughlin stated it was built in 1936. He doesn't know why. Mayor McLaughlin stated they will have their Engineer look at it. Replacing it with a new cement wall might be better. Comm. McLoughlin stated it might also be very expensive.

Mr. Moriarty asked what will be done with the bus. Mayor McLaughlin stated they will either repair it or try to get a used bus. Comm. McLoughlin stated they bought the bus for \$2,000 and it will cost upwards of \$6,000 to fix it. They will probably get a used bus. Mayor McLaughlin stated that they can get other estimates on the bus. It might be better to fix something they know rather than purchase a used bus that may not work so well.

Mr. Moriarty stated the Beach Club Manager, Wynn comes in to speak to the Commissioners in caucus and the members don't know what is going on. He stated problems are swept under the rug.

Mayor McLaughlin disagreed, stating problems are not swept under the rug. Mr. Moriarty may not know the outcome, but it should not be his concern. Mayor McLaughlin stated he is tired of hearing second-hand information which spreads around the Club and in most cases, is

not even true. If someone has a problem, he would like to hear it directly from that person, so that things are not blown out of proportion or misconstrued.

Mr. Moriarty asked if there were any plans to change the second floor of the restaurant since it is not being used. Mayor McLaughlin responded, no. It is very hot and breezy up there and people are just not using it. At 3 or 4 PM, people do go up there for a cocktail.

Mr. Moriarty asked if the bandstand will be rebuilt and Mayor McLaughlin stated it would be. Comm. McLoughlin asked if they were still going to connect the north and south decks.

There being no further comments or any further business, Comm. McLoughlin moved, seconded by Mayor McLaughlin, that the meeting be adjourned at 8:15 PM. Motion carried.
