OTHER BUSINESS

Mayor McLaughlin stated there is a broken cabana that the Public Works Department will be throwing away. Chris Rogers has asked if he could have it. Comm. Bolan stated he saw no problem with it as long as it is garbage. Comm. McLoughlin added that he will have to pick it up and transport it himself.

Mayor McLaughlin stated he spoke to Peter Avakian. He will have the bid packet for Allen Avenue on Friday. He wanted to meet with the Board to finalize some things on the Open Space project. It was decided that the best time would be before the Planning Board meeting on March 2, 2016 at 6:30 PM.

Mayor McLaughlin asked Mr. Heitmueller how hard it was to move the extra cabana to the beach and extend the platform. Mr. Heitmueller stated it could be done. He stated it is easier to extend the "L" because of the plumbing and electric. Mayor McLaughlin asked him to look at it and get back to him for the next meeting.

Ms. Osborn stated she attempted to get three quotes for the installation of a key switch for the Beach Club restaurant elevator. She has a quote from Schindler for \$2,900, a quote from Big Apple Elevator for \$690.00 and Sharp declined to submit a quote. Comm. Bolan suggested that the Borough Attorney handle it along with the other punch list items.

The Board next discussed the Easter Egg Hunt, and stated they would invite Loch Arbour and Interlaken. It will be held on Sunday, March 20, 2016 at 1 PM.

Mayor McLaughlin stated that the white planters on Main Street need to be replaced. He also stated there are four lights out on Main Street, one on the north side by Corlies Avenue, two in front of Buy Rite and one near the Loch Arbour border. Ms. Osborn stated she would let the electrician know.

Comm. Bolan stated he saw two people in Deal with metal detectors. Obviously, the State is not policing anything. He stated the Borough should just move forward.

PUBLIC HEARING

Comm. Bolan addressed Rose Meyer, who was present at the meeting and told her the Mayor mentioned that he had heard from her concerning the Borough's police officers. He stated they need to have a meeting to clear things up.

Ms. Meyer stated she really doesn't want to sit down with the Police Department. She has no interest. She wants to see if she can continue to create a happy, fun event without getting tripped up by overzealous, rude and overstepping police officers. When she had her event two weeks ago, a certain officer starting writing tickets. When her husband asked if he could run into the shop and make an announcement, he was told he better back down or he would be run in.

Comm. Bolan stated she is the only person they ever hear from who says anything negative about the Police Department. He hears nothing but praise from everyone else.

Ms. Meyers stated there is one rogue officer. No one wants to hear it.

Comm. Bolan replied that he wants to hear it. They need to get past the one incident that was 10 months ago and clear the air.

Ms. Meyer stated she didn't want to talk about it any further in this forum. Comm. Bolan stated this is a public body. This is the only forum.

Mayor McLaughlin stated they want to correct what is going on. They want to make it better.

Comm. Bolan stated the Mayor is willing to meet with Cpt. Schneider and Ms. Meyer. Mayor McLaughlin stated he would make himself available on March 3rd.

Ms. Meyer asked why she gets the brush off. She stated that 7 PM on the third was fine.

There was a short discussion on repairs of the Beach Club pumps.

There being no further business, the meeting adjourned to caucus. After reconvening, Comm. Bolan moved, seconded by Comm. McLoughlin that the meeting adjourn at 8:30 PM. Motion carried.
