RESOLUTION #9 A RESOLUTION AUTHORIZING THE EXECUTION OF PROFESSIONAL SERVICES CONTRACT WITH WILLIAM E. ANTONIDES & CO. FOR TEMPORARY CHIEF FINANCIAL OFFICER SERVICES

WHEREAS, the Borough of Allenhurst's ("Borough") Chief Financial Officer ("CFO") is temporarily unable to perform her duties, in order to comply with the requirements of N.J.S.A. 40A:9-140.10, the Borough must appoint a temporary chief financial officer; and

WHEREAS, N.J.S.A. 40A:9-140.10 permits municipalities to temporarily fulfill the requirement for a chief financial officer by appointment of a private entity to perform said duties for a term of no more than two consecutive one-year terms, subject to the approval of the Director of the Division of Local Government Services in the Department of Community Affairs; and

WHEREAS, Edward J. Simone, C.P.A., R.M.A., P.S.A. of William E. Antonides & Co. has submitted a proposal dated November 21, 2016, a copy of which is attached hereto and incorporated herein by reference, to provide temporary chief financial officer services in the absence of the Borough's CFO; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A: 11-1 et seq.) authorizes the execution of professional services contracts without competitive bidding; and

WHEREAS, Edward J. Simone, C.P.A., R.M.A., P.S.A. of William E. Antonides & Co. has completed and submitted a Business Entity Disclosure Certification, a Stockholder Disclosure Form, and a Political Contribution Form which certified that the firm has not made any reportable contributions to a political or candidate committee or the elected officials of the Borough of Allenhurst in the previous one (1) year period, and that the contract will prohibit the firm from making any reportable contribution through the term of the contract, as required by state law; and

WHEREAS, the acting Borough Clerk/Administrator has Certified, in writing, that sufficient funds are available for this purpose under the 2016 budget of the Borough of Allenhurst, a copy of which certificate shall be annexed to the original of this resolution.

NOW THEREFORE, BE IT RESOLVED by the Borough of Allenhurst that the statements contained in the foregoing preamble be and are hereby incorporated into this Resolution as if more fully set forth herein at length; and

BE IT FURTHER RESOLVED that, Edward J. Simone, C.P.A., R.M.A., P.S.A. of William E. Antonides & Co. be engaged to provide temporary chief financial officer services for the Borough of Allenhurst, as specified in the proposal of November 21, 2016 at a cost of \$4,000.00 per month (pro-rated for any portion of a month); and

BE IT FURTHER RESOLVED that, Edward J. Simone, C.P.A., R.M.A., P.S.A. of William E. Antonides & Co. be engaged to prepare the annual financial statement and annual debt statement of the Borough of Allenhurst for a cost of \$7,500 and \$825, respectively and to provide accounting services as specified in the proposal of November 21, 2016 for a cost not to exceed \$10,000.00; and

BE IT FURTHER RESOLVED that the Mayor is authorized to execute, and the acting Clerk to attest to an agreement between the Borough of Allenhurst and Edward J. Simone, C.P.A., R.M.A., P.S.A. of William E. Antonides & Co. to carry out the foregoing on a form approved by the Borough Attorney; and

BE IT FURTHER RESOLVED that the acting Clerk is hereby directed to cause to be published once in the official newspaper a brief notice stating the nature, duration, service and amount of the contract, and that the resolution and contract are on file and available for inspection in the office of the acting Clerk.

ITEMS FOR DISCUSSION

The Acting Borough Clerk discussed that the Tree Lighting event will take place on Saturday December 3rd. The event will start at the Firehouse at 3:00 pm with Santa, make your own ornaments, cookies and hot chocolate and an appearance by Bia. There will then be a hayride at 4:30 to the tree lighting with carolers. The tree will be lit at 5:00 followed by an appearance of the Dancers from the Studio. There will also be a fire-pit with marshmallows to roast.

The Acting Borough Clerk discussed whether or not the Borough should change the noise ordinance for the munition project at the beach by the Army Cor of Engineers because they would like to start at 7 am. The Commissioners said the 7:00 am should not be a problem since there are not many residents down by the beach at this time of year. If it becomes a problem the Borough will revisit the issue.

PUBLIC HEARING

Tim Moriarty asked if all the members at the beach club have pictures yet and if not could the Borough deny them entrance into the club. Mayor McLoughlin responded that the Borough would be policing it this year. Members will have to get their pictures by a certain prescribed date then they will not be allowed in. All security entrances should be able to take pictures. The Borough will also work with our Technology representative to see if the pictures can be audited beforehand to determine who still does not have pictures.

Tim Moriarty asked if the Borough had wifi in its budget for the beach club for 2017. The Acting Borough Clerk responded that it is currently being looked into and if it is not too costly it will be put into the budget.

Tim Moriarty asked if anything else has been done with the Butcher Shop. The Acting Borough Clerk stated that there were some garbage and health violations that DPW were currently dealing with and after that is settled a letter will go out strongly recommending that they attend a public meeting to discuss all the issues.

Tim Moriarty asked if the Borough could put umbrellas or canopies up on the rooftop. Mayor McLoughlin responded that it is too windy and could be a hazard. He also stated they looked into Pergolas but that would be over the weight requirement.

There being no further comments, public hearing was closed.

There being no further business or, Mayor McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 8:15 PM. Motion carried.

After reconvening, Mayor McLaughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 9:30 PM. Motion carried.
