A letter will go out to all businesses advising them of the meeting.

The awning/curtain requested by Mr. C's restaurant was discussed. Currently there is a draft coming in from the service bar to the restaurant. The tenants had requested that a curtain/awning be installed. The cost is \$175. The Board of Commissioners approved the purchase.

The calibration of the traffic light at the Railroad Crossing was discussed. It appears that the light was never calibrated with the Railroad Crossing when it was installed years ago and the do not turn left signal as you leave the bank is not working. The cost of calibration is \$590. The Commissioners felt that the traffic light is working fine and it has not been an issue therefore they did not think the expense was warranted.
