#### **ITEMS FOR DISCUSSION**

Mayor McLoughlin gave a brief discussion on the Business Owners meeting that was held prior to the meeting. The topics discussed with the Business Owners were the sign and noise ordinance, multiple businesses in one location and parking. The Business Owners were told that the Borough would be looking into enforcing the sign ordinance as many businesses have multiple signs in their windows. The Borough will also examine the ordinance to see if it could be amended to include banners that a few of the business owners already have. Mayor McLaughlin asked the Borough Administrator to have the Zoning Officer go around to take an inventory of what signs businesses had so the Borough could figure out the best way to enforce the ordinance.

Mayor McLoughlin also discussed the multiple businesses in one location. It is becoming a problem and there is overcrowding in the summer and then vacant stores in the winter. He asked the Borough Attorney to look at the zoning ordinance to see if the Borough could limit the amount of businesses in one location. The Commissioners feel that too many businesses in one location in the summer can become a safety issue.

Commissioner Bolan asked if the Code Official could do an inspection of the hedge/tree/bushes that are intruding on the sidewalks as you cannot walk by and it is becoming a safety issue. Mayor McLaughlin asked the Borough Administrator to have the Code Official inspect the whole town. Anyone not in compliance should get 14 days to cure it or the town will cut the hedges.

#### **PUBLIC HEARING**

Mayor McLaughlin offered to the public if they had any questions or comments and there were none. There being no further comments, public hearing was closed.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 8:30 PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 9:00 PM. Motion carried.
