**WHEREAS**, the report has been made available to the public for at least 48 hours prior to the adoption of this Resolution awarding the Lease; and

**WHEREAS,** the report recommended that the Lease be awarded to 889 Snacks, LLC and its owner, Paul K. Hallman, as his proposal was the only one received and thus was the only option available for the Borough to secure a Tenant for this season.

There will be ribbon cutting ceremony for the New Allen Avenue Park/Beach entrance on Friday, May 26<sup>th</sup> at 5pm. The Borough Administrator will invite the Freeholders, Press, residents, employees, business owners and beach club residents to attend. She will also ask the Beach club restaurant Mr. C's if they would like to offer a happy hour afterwards.

### Beach Club Issues

- Betty Anny McCarthy (Resident- Member) is requesting Lindsay Horowitz (Resident Member) to take over A-13. Lindsay will give up A-17. Commissioners Approved
- Alan and Rosemary Traettino (Non-Resident Member) (Locker I-7) are requesting that the Kleeman members (Non-Resident) in their locker be place "on-hold" for the 2017 season due to a surgery and recovery period that will take up most of July and August. They want to ensure that the Kleemans will be able to rejoin next season. Commissioners approved pending Doctor Notice.
- Meridith Pennotti (Non-Resident Member) requesting that her nephew, Jordan Cortlett (Non-Resident was a member up until 2013) and his wife, Natalie be permitted to join the beach club and be added to the locker. The Pennotti's wished to mention that they have been members of the club for nearly 40 years. If this request is approved the Pennotti's would have 13 people in their locker. Commissioners denied this request.
- Christine Applegate (Non-Resident Member) is requesting that the Alto family (Non-Resident and not currently members) be allowed to join the beach club and be added to their locker. They state that their current locker mate is not returning. Given they have a child starting college and another on deck, they are citing that it would make it financially feasible for them to continue membership if the Altos were in their locker. The Altos are "like family" and trust them with their children. Commissioners denied this request.
- Sarina Franco (Resident Member 317 Spier) would like her Nephew Jackie Ovadia and his family be allowed to join. Jackie advised that the Ovadia family will be living with her in Allenhurst for the summer. The Ovadia family were members last year because they rented their own home in Allenhurst. They are now renting in West Allenhurst. Commissioner advised they need further clarification. Requested this be put on agenda for next meeting and Mrs. Franco and

Ovadio family should attend.

- -Loreta Cafolla (Non-Resident Member) would like to add Annette Borgia to her locker. Annette is the cousin of Lillian Fischer who is currently in Loreta's locker. Commissioners denied this request.
- Lisa Boice requesting Maria Francisco rejoin. She was kicked out of her locker last year and she did not join. Commissioners approved this request.
- Robert and Greg Fernicola and Lorraine Sheehan Fernicola have asked to put the cabana in the name of the family LLC. Commissioner Bolan stated that principals cannot be an LLC. They must be attached to a real person. Greg Fernicola will no longer be the principal. Lorraine Fernicola Sheehan and Robert Fenicola will now be co-principals. There will be no passing down to other principals after that. Upon both of their deaths, or when they cease to be members, they will no longer have a cabana. Robert Fernicola will now come off the non-resident cabana waiting list and will pay non-resident rates. Lorraine Sheehan Fernicola will receive resident rates as long as she is resident. If she rents her house she will pay non-resident rates.
- Fern Aaron requested to join new members to her locker that are not currently members. The Commissioners denied this request.

Guest Credits were discussed and how long a member can keep ten before they expire. Guest credits will be good for 2 seasons.

Marc Heitmueller, Beach Club Facilities Manager, discussed various Beach Club projects. The new pump has been installed and the slide fixed. The small pump cannot be fixed because it is not cost effective. All cabanas have been moved to the beach.

Mayor Mclaughlin brought up the deal parking situation. Deal is trying to make everyone have a permit to park. This could cause more people to try to use the Deal Beaches by Allenhurst without paying and using our public restroom facility. Mayor McLaughlin will write the Mayor of Deal regarding the situation.

#### **PUBLIC COMMENTS**

Tim Moriarity asked if it was true that you cannot buy individual passes. Mayor McLaughlin responded, yes.

The Mayor also asked if a member could use guest credits next year if they were not a member. The Borough Administrator/Acting Clerk responded, no. The Borough's IT person is ensuring g that those credits are deleted from the system. The question was also asked if the guest passes were attached to the locker or the person. Commissioner Bolan stated they are attached to the person.

There being no further comments, public hearing was closed.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 8:20 PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 9:20. Motion carried.
