ITEMS TO DISCUSS

The June 13th meeting will be held at the firehouse with a special proclamation for Chief Richter who is retiring on June 30th.

The ribbon cutting ceremony for the New Allen Avenue Beach Entrance will be on Friday, May 26th at 5:00pm.

Cabana member Jane Hughes requested Lauren Hughes, who is her daughter and a member of the beach club for at least 5 years, become co-principal. Commissioners approved.

Mr. O'Rourke from the school board gave a brief presentation. The Board of Education of the Borough of Allenhurst filed a petition with the Commissioner of Education of the State of NJ requesting that the Commissioner permit the severance of the sending-receiving relationship between the Allenhurst Board and the Board of Education of the City of Asbury Park and approve sending-receiving relationships with the Boards of Education of the Borough of West Long Branch and Shore Regional High School District. There was no opposition from the Asbury Park Board, the West Long Branch Board or the Shore Regional Board. The Bureau of Controversies and Disputes instructed the four boards of education to make formal announcements. The public has 20 days from the date of the announcement to submit comments to the Commissioner of Education of NJ. The announcement is on file with the Acting Borough Clerk.

Mayor McLaughlin asked how long it will take the Commissioner of Education of NJ to make the decision. Mr. O'Rourke said it can take up to a year but doesn't see any problems with getting approval. Commissioner Bolan asked how this will affect the students that go to Red Bank regional school. Mr. O'Rourke said they will probably let anyone finish out their school year but it has not been decided yet. Mayor McLaughlin asked if there was a formula for the cost per pupil. Mr. O'Rourke responded that it is a flat rate at approximately \$12,000 which is less expensive than both RBR and Asbury Park. The Acting Borough Administrator asked how many children are in Allenhurst that attend school. Mr. O'Rourke said approximately 30-35 and they attend all different types of schools-vocational, Catholic, Deal and RBR.

Beach Club member Sarina Franco requested that her niece and nephew who used to rent in Allenhurst and were members of the club be able to join the beach club even though they no rented here. She stated they will be living with her this summer while their house in West Allenhurst is being renovated. Her request had previously been denied. Commissioner Bolan stated that the Borough has rules that in order to be able to join as a renter they must have a lease and there could be no lease if they were just staying with Mrs. Franco. Mayor McLaughlin stated that the Borough has had problems in the past and they are trying to limit membership as the Beach Club is getting too crowded. Commissioner McLoughlin added that the rules of family members joining are limited to rules of succession—mother, father, daughter, son and grandchildren. Mayor McLaughlin stated that if they gave an exception and allowed Mrs. Franco's nephew to join it could open up a can of worms and they would have to let others join as well and that they have already have denied similar requests. Commissioner McLoughlin stated they are welcome to use guest passes.

Mayor McLaughlin stated that he received an email from a resident asking if speed bumps could be placed on the new Railroad Plaza parking lot. The Acting Borough Clerk will speak to the Captain about it.

The Acting Borough Clerk gave a brief discussion of Beach Club and town projects. Ms. Campagna also discussed the NJ Transit parking signs and whether or not they could be taken down. The Borough had just paved Railroad Plaza as part of an open space grant and had asked NJ Transit to split the cost of paving since mostly NJ transit commuters park in the lot. NJ

Transit had informed the Borough that they only own from the tracks to the curb and therefore would not split the costs. NJ Transit continues to keep their signs that state "Parking for NJ Transit Commuters only." The Borough Attorney stated that the Borough can take them down.

PUBLIC HEARING

Tim Moriarty questioned whether the correct beach club booklet was on the beach club website as the dates appeared incorrect. Mayor McLaughlin stated that the website is not fully maintained until the beach club opens. He also stated that the correct booklet was emailed out. Next year the Borough is looking into combining the beach club and town website so everything will be up to date.

There being no further comments, public hearing was closed.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 8:30 PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 11:30 PM. Motion carried.
