ITEMS FOR DISCUSSION

There was a brief discussion on the installation of the floating dock at the lake at Railroad Plaza Park. Doug Caron, DPW Supervisor, explained how it should be installed. The DPW will install in the fall when they get time. The Administrator/Acting Clerk will discuss with the engineer how it should be installed. Also, she will discuss with the engineer about having the loose stone around the new equipment containerized.

The Borough had received a complaint about trainers working out with clients on the boardwalk. Currently there is no ordinance that covers this situation. The Commissioners stated that if it happens again to contact police to handle the situation. If it becomes a problem then they are to issue a summons.

Theresa Santoro, an Allenhurst Beach Club Member, requested that she be able to clear out her cabana on September 11th, the day after the official closing date of the club for 2017. The Commissioners denied this request citing that the beach club closing date of September 10 is final, no special extensions for access will be granted. All member must empty lockers and cabanas by the close of the day on September 10.

Dani Risi requested two additional weeks to sell merchandise at the beach club. Since there were no other requests, her request was approved.

There was a brief discussion on the potential closing of the railroad crossing at Lake Avenue. The DOT diagnostic team had performed an additional study on how many cars use the crossing. Their study was done in July, as requested by the Borough, because last time they conducted the study off-season. The DOT study findings were approximately only 50 more cars than last time and most cars used the crossing as a "cut through" to avoid the train. They will send a Diagnostic Team in September to discuss the official findings with the Acting Borough Clerk/Administrator and Engineer. After that, the Borough can request a public meeting to appeal their decision and present finding as to why they should not close the crossing, and also to allow the public to voice their concerns. The Borough will have the police, fire and EMS also attend to present the public safety reasons for leaving the crossing open. Mayor McLaughlin stated that the Borough has contacted Senator Beck for assistance in helping to reverse the DOT's potential decisions. Mayor McLaughlin also stated that the Borough will send out a letter informing residents of what is going on since it appears there is misinformation around town.

Mayor McLaughlin discussed engaging Hyer & Gruel to review the redevelopment plan. Specifically to update the master plan and review the redevelopment plan and ensure that it

conforms with the master plan and all ordinances and set back requirements that have been passed since said time.

PUBLIC HEARING

Tim Moriarity stated that having the crossing close at Lake Avenue will affect the demolition of the water tower and construction of the monopole as the trucks might not have enough clearance to enter. Mayor McLaughlin stated that was a good point and will be noted in our findings to the DOT.

Mr. Moriarity also asked if the Borough would put a "do not enter" sign on Ocean Place in front the beach club. He noticed someone going the wrong way down the street. Commissioner Bolan stated that he did not think the signs would help as people who don't follow signs will still not follow them even if a "do not enter" sign is installed. If it continues to be a problem the Borough will look into it.

Mark Horowitz asked if cars were allowed on the beach to empty cabanas, Mayor McLaughlin stated that there is an ordinance in place that will not allow it.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Mayor McLaughlin that the meeting move to executive session at 8:20 PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 9:10 PM. Motion carried.
