RESOLUTION #2017-227 A RESOLUTION TO PROCLAIM OCTOBER 10, 2017 – PUT THE BRAKES ON FATALITIES DAY

WHEREAS, Across the nation, traffic crashes caused 35,092 fatalities in 2015, and are the leading cause of death for young people ages 15 to 34; and,

WHEREAS, In New Jersey, 603 individuals lost their lives in traffic crashes in 2016; and,

WHEREAS, Pedestrian-related crashes accounted for 27.5 percent of the State's traffic fatalities, while 19 percent of all fatal crashes involved a distracted driver; and,

WHEREAS, Motorcyclists, bicycle riders and pedestrians face increased risks on New Jersey's roadways, as people opt for alternative modes of transportation; and, WHEREAS, 66 motorcyclists, 18 bicyclists and 166 pedestrians were killed in New Jersey in traffic-related crashes in 2016; and,

WHEREAS, Safer driving behaviors such as buckling up, every ride; obeying posted speed limits; stopping for pedestrians in crosswalks and using crosswalks when walking; avoiding aggressive driving behaviors; never driving impaired; wearing proper safety gear while riding a motorcycle or bicycle; and, focusing solely on driving by avoiding distractions, can dramatically reduce the number of traffic-related injuries and deaths;

NOW, THEREFORE, BE IT RESOLVED, By the Board of Commissioners of the Borough of Allenhurst that October 10, 2017 be proclaimed Put the Brakes on Fatalities Day®, and call upon everyone to put these lifesaving behaviors into practice to improve safety on the roadways in our community and through the State.

ITEMS FOR DISCUSSION

There was a brief discussion on the Diagnostic Meeting held today with NJ Transit and the Department of Transportation (DOT), the Mayor, Commissioner Mcloughlin, the Borough Administrator and the Borough Engineer about the Allen Avenue crossing. The purpose of the meeting was to discuss the possible closing of the Allen Avenue Crossing. The Mayor stressed that there has not been a final ruling yet and that the Borough is totally against the closing and is working diligently to oppose it. The DOT's rational for closing the crossing is due to costs as it costs approximately a half a million dollars to upgrade a crossing and the state has limited budgets. The DOT/NJ Transit will be informing the Borough in about a month about their recommendations whether or not it should be closed. If the recommendation is to close, the Borough will have 30 days to submit their appeal to the Commissioner of Transportation. The Mayor stated that the Borough has asked Congressman Pallone and Senator Beck to assist in the appeal.

Bob Scally asked how the Borough will appeal. The Mayor stated that we will send reports from the Borough's police chief and fire chief. The Borough Engineer will also assist in the process.

Donna Clauss, asked if the crossing was to close what would be put up as a barricade. The Borough Administrator/Acting Clerk stated that the Borough has requested the DOT to send pictures from other towns that have had crossing closed to get ideas of what the Borough can request. The Borough told the DOT it would have to be aesthetically pleasing and fit in with the landscape of the town. The DOT said they could put up a barricade and line it with trees.

Bob Scally asked if the Borough had any plans to replace the boardwalk with TREX boards. The Mayor stated there are no plans to do that and the Borough has not had any complaints.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Commissioner Bolan that the meeting move to executive session at 7:45 PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Mayor McLaughlin that the meeting be adjourned at 9:30 PM. Motion carried.
