ITEMS FOR DISCUSSION

The DOT had conducted a study and recommended the closing. The DOT had performed another traffic study in June that yielded similar results as the previous study. The Mayor stated that the Commissioners have a meeting set up in Trenton with the DOT this month to appeal their decision. The Mayor stated that they will also ask our police and the Chief to write letters with their concerns and recommendations. The Mayor also stated that Borough is researching whether there are any easements that would preclude the closing. He also stated that Senator Pallone and Senator Beck are also helping the Borough with the appeal. The Borough also did an OPRA request for the costs associated with the upgrades for the Railroad crossings.

Rich Kaminski asked what the number of cars needed in the traffic study to keep the crossing open. The Mayor stated the DOT had mentioned 2000 but the traffic study only yielded 500.

Mrs. Varley asked if they would be putting up cement barricades if the crossing was to close and was worried about the safety. The Mayor stated that nothing had been decided yet. The Commissioners will voice the concern at the meeting in Trenton.

Tonya Tomaino asked why they have to rebuild the crossing. The Mayor stated Federal Mandate says it must be done due to the signals and gates not being up to standards. Mrs. Tomaino asked could we just leave the crossing as is. The Mayor stated the Borough has asked but DOT said no.

Melanie Olon from Loch Arbour asked if the Borough contacted the clerk from Loch Arbour to put out an email about the closing. She said the more voices the better. The Mayor stated although the numbers help the DOT is looking for more concrete reasons such as traffic safety.

Rich Kaminski stated the reason he felt the numbers were down for the number of cars using the crossing was due to Benson Park not being used. If the Borough redeveloped, it maybe there would be more cars. Commissioner McLoughlin stated that JCP&L is in the process of selling their property and the property might be redeveloped. He also stated the Borough will also use this as part of their appeal in Trenton.

Ross McIver asked if the DOT did a traffic study. The Mayor responded, yes. Mr. McIver also asked if any other towns had fought the DOT and won. The Mayor responded, no. The Mayor also stated did an OPRA request for the traffic studies that the DOT conducted.

Bob Scally stated that by closing the crossing it would create more traffic congestion. Christine Petillo expressed the same concern.

Mrs. Vignone stated that 25 years ago there was an accident at the crossing when the gates were working. She can't imagine how unsafe it will be with an unattended crossing, "It's a tragedy waiting to happen."

Michael Prince asked if the DOT set up a time line for the closing. The Mayor stated, no.

Theresa Santoro stated that if the crossing closes and barricades were put up it would create a safety concern as many kids would try to jump over the barricades to get to the basketball courts.

Patty Englert asked about the Feral Cat situation and if there was anything the Borough was doing about it. The Mayor stated that the Borough is in the process of researching a program with the ASPCA. The Borough will also look into an ordinance but it is a hard ordinance to enforce.

Trish McLoughlin asked if the Borough has an agreement with the ASPCA for trapping the cats. The Mayor reiterated that the Borough is researching it.

Mr. DeMurley stated that she is tired of being harassed about feeding the cats. She stated she is not feeding them.

Debbie Higgins stated that there is a woman in town called "The Cat Lady" that might take them. She will forward the information to the Borough Administrator.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Commissioner Bolan that the meeting move to executive session at 8:10 PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Commissioner Bolan that the meeting be adjourned at 9:25 PM. Motion carried.
