WHEREAS, the Company wishes to engage the Borough, in its capacity as redevelopment entity pursuant to the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1 *et seq.* (the "**Redevelopment Law**"), in the negotiation of a redevelopment agreement and other related agreements with respect to the Redevelopment Area (the "**Redevelopment Activities**"); and

WHEREAS, the Borough wishes to enter into an escrow agreement with the Company in order to defray the cost of such Redevelopment Activities,

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Borough of Allenhurst that the statements contained in the foregoing preamble be and are hereby incorporated into this Resolution as if more fully set forth herein at length; and
