ORDINANCES FIRST READING

ORDINANCE #2018-03 "BEACH REGULATIONS"- FIRST Reading

ORDINANCE#2018-03 AN ORDINANCE REVISING CHAPTER X OF THE BOROUGH CODE OF THE BOROUGH OF ALLENHURST ENTITLED "BEACH REGULATIONS."

Offered By: Mayor McLaughlin Seconded By: Comm. McLoughlin

WHEREAS, the Borough Council of the Borough of Allenhurst has determined that it is in the best interests of the community to revise certain portions of its existing Borough Code concerning the Beach Regulations to address the needs of the community;

NOW THEREFORE, BE IT ORDAINED by the Borough of Allenhurst, County of Monmouth, State of New Jersey, that the Borough Code of the Borough of Allenhurst be and is hereby amended and supplemented as follows:

I. Chapter X, section 1.6(d) be and is hereby revised to delete the existing subsection and replace it with the following:

d. Guest Charges. Each individual bathing guest (age 3 and older) using a member's bathhouse or cabana –one (1) guest pass per day; Children, age 3 and under will be admitted, no charge. These 2018 Guest passes will be valid for guests during the 2018 season, when accompanied by a registrant of the Allenhurst Beach Facilities.

Packages of 2018 Guest tickets will be sold in groups of ten (10) passes for \$150.00. If purchased on or before May 31, 2018, the packages of 2018 Guest tickets will be sold at the discount price of \$130.00. There is no limit on the number of packages that may be purchased but, be advised that they are **only valid during the 2018 season**.

II. Chapter X, section 1.6(h) be and is hereby revised to delete the existing subsection and replace it with the following:

h. A recreation program shall be established which shall be open to all children who are members of the Allenhurst Beach Club between the ages of five (5) years and twelve (12) years at the discretion of the Recreation Director. The program shall run for seven (7) weeks, during the Beach Club season from 10:00 a.m. to 3:00 p.m., Monday through Friday and will not run on those days the Beach Club is closed for inclement weather or any other unforeseen circumstance.

The cost for participation in this program will be four hundred fifty (\$450.00) dollars for the first child and four hundred (\$400.00) dollars per child for additional children from the same family. These fees are exclusive of any charges for additional day trips or other special events as the Recreation Director may offer. Participants will be notified of the fees for such events on an "as offered" basis.

And, it is further

ORDAINED that except as herein above provided, the remainder of Chapter X, BEACH REGULATIONS, shall remain unaltered and in full force and effect; and it is further

ORDAINED that the provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of this ordinance shall stand notwithstanding the invalidity of any part; and it is further

ORDAINED, That this Ordinance shall take effect after publication and adoption according to law.

ITEMS TO DISCUSS

Matt Mariano, from the Borough Engineer's office, gave a brief presentation on the Route 71 project. He advised there is an issue with resetting the slate sidewalks and curbs. Mr. Mariano advised as to what is believed to be the choices for replacement. The Mayor said there is a letter from 2013 stating that slate had to be reused for sidewalks and curbs. Comm. McLoughlin asked if the state has the right to replace the curbs and sidewalks. The Borough Attorney asked if the

project includes the right of way. Mr. Mariano advised that it does. The Borough Attorney stated that the Borough does not have a leg to stand on. Comm. Bolan stated that Allenhurst is a federal historic district and don't the contractors have to adhere to those requirements? Comm. Bolan also stated that holding up the project is not something the Borough wants to do. Comm. Bolan thinks patching would look horrible and also be a safety hazard. Comm. Bolan thinks concrete would be a better idea. The Mayor disagreed, and stated since we are an historic district and should have slate replaced. Mr. Mariano stated that he does not believe there is enough salvaged slate to replace for the curbs and more would have to be purchased. The Mayor wants the slate salvaged and wants to see the statute the DOT is citing. The Mayor does not agree with replacing with concrete. Comm. Bolan thinks the Borough should make it all uniform. Comm. McLoughlin and Comm. Bolan agree that stamped concrete would be best.

The Borough Administrator advised that to address the situation with the underground storage tank at the Fire House and LSRP is needed and it went over budget. The Commissioners agreed to proceed.

Mr. Mariano have a brief discussion on the playground project.

The Mayor advised of changes to the dispatch at the Police Department. The Mayor advised that the Police Department is a huge chunk of the Borough budget. The Commissioners are obligated to keep the budget in check to keep the taxes down. The cost of dispatch in Allenhurst is significantly higher than neighboring towns or what it would cost at the County level. The Borough considered getting rid of the dispatch department completely. In an attempt to keep our own dispatch the Chief looked into ideas to give cost savings and the commissioners agreed. It is all about the cost, and nothing personal, and making these changes allows the Borough to not have to disband the department. The changes involve a salary cap.

Melissa Dueer asked would the cap be for future employees or would it involve salary reductions. Comm. Bolan stated it would involve salary reductions and advised this is an alternative to eliminating the jobs completely. He stated it is not debatable since the Borough could get the same services from the county for a big cost savings. The salaries for Allenhurst dispatch is out of line compared to other towns that are bigger.

The Mayor advised that this has not been taken lightly and has be discussed for a long time and with a lot of research.

Jason Henry asked what overtime would be based on and would they be paid. Comm. Bolan stated that overtime would be paid at the rate of capped pay. The Chief stated that he was charged from the Commissioners to do the research. Comm. Bolan said it was not the Chief's recommendation. The Chief lobbies for them. The Chief works for the Commissioners.

The Mayor reiterated that it was not personal and when he spoke with other towns, they invariably could not believe Allenhurst still maintained their own department. Comm. Bolan said it was an objective review, because an non-objective review would be to get rid of the dispatch department.

PUBLIC COMMENTS

Tim Moriarity asked if homeowners could offer to give the extra slate for the curbing on Route 71. Comm. McLoughlin state that the state is not offering that as an option. There being no further comments, public hearing was closed.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 8:15 PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 9:00 PM. Motion carried.
