# ORDINANCE#2018-11 AN ORDINANCE REVISING CHAPTER X OF THE BOROUGH CODE OF THE BOROUGH OF ALLENHURST ENTITLED "BEACH REGULATIONS."

Offered By: Mayor McLaughlin Seconded By: Comm. McLoughlin

**WHEREAS,** the Borough Council of the Borough of Allenhurst has determined that it is in the best interests of the community to revise certain portions of its existing Borough Code concerning the Beach Regulations to address the needs of the community;

**NOW THEREFORE, BE IT ORDAINED** by the Borough of Allenhurst, County of Monmouth, State of New Jersey, that the Borough Code of the Borough of Allenhurst be and is hereby amended and supplemented as follows:

- I. Chapter X, section 1.6(d) be and is hereby revised to delete the existing subsection and replace it with the following:
  - d. Guest Charges. Each individual bathing guest (age 3 and older) using a member's bathhouse or cabana one (1) guest ticket per day; Children, age 3 and under will be admitted, no charge. These 2018 Guest Tickets will be valid for guests during the 2018 season, when accompanied by a registrant of the Allenhurst Beach Facilities.

2018 Guest tickets may be sold individually, throughout the season at the discretion of the Borough, for \$15.00 per Guest ticket. Individual 2018 Guest tickets are good for one individual, for one day's admission. Said Individual 2018 Guest tickets will only be valid during the 2018 season.

Packages of 2018 Guest tickets will be sold in groups of ten (10) passes for \$150.00. If purchased on or before May 31, 2018, the packages of 2018 Guest tickets will be sold at the discount price of \$130.00. There is no limit on the number of packages that may be purchased but, be advised that they are **only valid during the 2018 season**.

And, it is further

**ORDAINED** that except as herein above provided, the remainder of Chapter X, BEACH REGULATIONS, shall remain unaltered and in full force and effect; and it is further

**ORDAINED** that the provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of this ordinance shall stand notwithstanding the invalidity of any part; and it is further

**ORDAINED**, That this Ordinance shall take effect after publication and adoption according to law.

**WHEREAS,** Pursuant to the Police and Fire Retirement System and the Borough's Personnel Policy, employees who retire from the P.F.R.S. with the required number of years of service; are entitled to certain benefits; and,

**WHEREAS,** Wray Burritt meets the retirement system requirements; **NOW, THEREFORE, BE IT RESOLVED,** By the Board of Commissioners, the following retirement benefits be confirmed:

- 1. Medical insurance, for the retiree and his family, through the NJ State Health Benefits Program, effective September 1, 2018 until the death of the retiree. Retiree is responsible for 19% of the premium that is billed to the Borough. Payment is due the 1<sup>st</sup> of each month from the retiree, payable to the Borough of Allenhurst. The Borough will allow five days grace period, after which coverage can be cancelled.

Holiday Pay earned for 2018 - \$2,746.31 to be paid on September 15, 2018.
