AN ORDINANCE TO AMEND THE ORDINANCE ENTITLED, "AN ORDINANCE FIXING THE SALARIES OF ALL APPOINTED OFFICIALS AND EMPLOYEES OF THE BOROUGH OF ALLENHURST IN THE COUNTY OF MONMOUTH AND STATE OF NEW JERSEY (EXCEPTING MEMBERS OF THE POLICE DEPARTMENT)"

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF ALLENHURST, COUNTY OF MONMOUTH, AS FOLLOWS:

SECTION I. RESOLUTION #2019-44 A RESOLUTION TO AUTHORIZE COUNTY TO PERFORM AERIAL SPRAYING FOR MOSQUITOS

Offered By: Comm. McLoughlin Seconded By: Comm. Bolan

WHEREAS, The Monmouth County Board of Chosen Freeholders, pursuant to N.J.S.A. 26:9-27 et seq. has elected through its Mosquito Control Division to perform all acts necessary for the elimination of mosquito breeding areas and/or to exterminate mosquitos within the county; and,

WHEREAS, The County has instituted an Integrated Pest Management Program consisting of surveillance, water management, biological control, and chemical control to exterminate the mosquito population within the County of Monmouth; and,

WHEREAS, Prior to conducting aerial dispensing operations over a designated "congested area", the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 13.51), to secure prior written approval from the governing body of the political subdivision over which the aircraft is to be operated; and,

WHEREAS, The Borough of Allenhurst is designated as a "congested area" by the Federal Aviation Administration and the county has requested that this governing body consent to its proposed aerial dispensing operations;

NOW, THEREFORE, BE IT RESOLVED, As follows:

- 1. The Governing Body hereby authorizes the County of Monmouth Mosquito Control Division or its agent to apply pesticides by aircraft for mosquito control in certain areas of the municipality designated by the County as being either larval mosquito habitat or areas bordering high populations of mosquitoes constituting either a nuisance, a health hazard, or both with the understanding that:
 - a. the County shall utilize pesticides, application equipment and aircraft that are approved for aerial applications by the applicable Federal (USEPA) and State (NJDEP) agencies; and,
 - b. such operations will be performed in compliance with applicable Federal and State regulations, and
 - c. the County will notify the police department of each municipality over which aerial pesticide operations are planned prior to commencement of such operations.

ITEMS FOR DISCUSSION

The Borough Administrator discussed the contract with the Humane Society regarding Feral Cats. The Associated Humane Society has discontinued their TNR program. The Humane Society no longer has the TNR associate on staff. The program was not a success. They were overwhelmed and could not provide the TNR services as were originally offered.

With the Humane Society full service contract which Allenhurst will maintain in 2019, the following is what will happen if a resident calls about a feral cat:

1. If someone has been feeding cats and wants to fix them, the Humane Society recommends that they call MSPCA or the spay & neuter clinic in Holmdel. These 2 facilities have the means to do many cats at a reasonable cost. The Humane Society has only one vet and are unable to do TNR on a large scale or as quickly as the two clinics mentioned above.

- If the person who is feeding cannot afford to pay regular clinic fees, the Humane Society will do what they can to accommodate and will ask for a donation to help.
- 2. If someone calls about a cat they are not feeding, the Humane Society will recommend that the resident trap the cat. Once trapped, the Human society will retrieve the cat. If the cat is ear tipped and healthy, the Humane Society will usually release it back in the area and give the property owner a list of cat deterrents to use. If the cat is not ear tipped/fixed, the Humane Society will decide after 7 days if the cat should be adopted, fixed and returned, relocated, or euthanized. However, many things factor into making these decisions.
- 3. The Human Society does not provide traps. The resident should obtain their own trap. The only situation in which the Humane Society will provide a trap is when there is a very sick animal and there is a danger to the neighborhood.

PUBLIC COMMENTS

No Public Comments

There being no further business or comments, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 7:45PM. Motion carried.

After reconvening at 8:10PM, Allenhurst Powerhouse LLC, developers of the JCP&L property, asked to make their case on the redevelopment agreement.

The developers stated they looked over the draft redevelopment plan and would like the municipality to consider the following changes:

I. East Side

a. The plan calls for 2 ½ stories maximum. The garage level as designed is a living level and might be fully above ground. The developer is requesting 3 Stories not to Exceed 35 Feet, consistent with the plans they have shown at every meeting.

II. West Side

- a. The developer looked at every option for increasing parking and due to physical restraints can only provide a total of 188 spaces including off street parking as set forth below. Using RSIS of 1.8/1bdrm and 2.0/2bdrm, yields a requirement of 162. They can only meet that requirement using on-street parking or a requirement of 1.8 per unit using only off-street. The developer believes this is a reasonable reduction given the proximity of the project to mass transit and the fact that parking will not be assigned, allowing for the maximum efficiency in utilization.
 - i. 27 Spaces on Main Street
 - ii. 10 Spaces on the East Side
 - iii. 135 Spaces within the garage
 - iv. 16 Spaces on Lot 4
- b. The developer noted that the plan requires additional parking for retail and restaurant, but RSIS provides that parking shall be shared in mixed use developments. At a minimum, retail and restaurant should be allowed to utilize on-street parking.
- c. The developer is proposing 84 Units which is driven by the building configuration. The breakdown is as follows:
 - i. 51 (2) Bedrooms, Average Size of 1,200 sft
 - ii. 33 (1) Bedrooms, Average Size of 900 sft
 - iii. The plan as drafted has a minimum unit size of 900 and an average of 1,200. They can meet the minimum, but the total average is 1,050
 - iv. The unit split between 1 and 2 Bedroom Units may change

III. Affordable Housing

- a. For the avoidance of doubt all affordable housing the developer will provide 10% of total units on the West Side property
- b. Assuming 31 Townhomes and 84 Apartments, the developer will provide 11 Units on the West Side on the first floor of residential units.

IV. Eminent Domain

- a. The developer asked if the adjacent lot to the West be included as part of the Redevelopment Area.
- V. No Summer Construction Ordinance

- a. The developer needs Relief from that ordinance. They don't propose hammering out the details here, but are asking if the ordinance would apply to redevelopment areas and can be addressed on an individual basis in a Redevelopment Agreement (RDA).
- VI. The developer would like to know if the Borough is considering making a liquor license available exclusively within the redevelopment area.

The Governing Body took their requests under advisement and will discuss.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 8:30PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 9:15PM. Motion carried.
