# BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF ALLENHURST, COUNTY OF MONMOUTH, AND STATE OF NEW JERSEY AS FOLLOWS:

**ORDAINED** that the provisions of these ordinances are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of these ordinances shall stand notwithstanding the invalidity of any part; and it is further

**ORDAINED**, That this Ordinance shall take effect after publication and adoption according to law.

# **ITEMS FOR DISCUSSION**

#### **Beach Questions:**

- -Arthur J. McGinnis Cabana 14 is requesting that Kirsten McGinnis be made a coprincipal on the cabana. Kirsten has been a member and in the cabana for more than five years **Request was approved**
- -The Harringtons (Nancee) Locker L- 18 are requesting that their membership be "frozen" for this season as they will not be around enough to use it. They were new members last year **Request was denied.** The Council advised that we do not "freeze" memberships. As such, they can provide no guarantee that Ms. Harrington will be able to join the beach club in the 2020 season. A new membership would be subject to availability and the approval of the Mayor and Council.
- -Dennis Donato Wants to change the principal on the locker to his daughter Ellen M. Donato. Ellen has been a member for 27 years. Also, he is not joining his wife this season because she is having knee surgery, but wants to confirm that she can rejoin next year without issue. **Request was approved.**
- -Peter DiNardo is requesting reimbursement for the Guest Passes of the 2018 season.Peter was in a major automobile accident and underwent back surgery which caused him to miss a considerable amount of the 2018 Season. **Request was denied**

#### **PUBLIC COMMENTS**

- The Mayor asked for a status on the New Pavilion at the Allenhurst Beach Club. The Borough Administrator advised that the footings are being done this week and construction will be starting in the next few weeks.
- The Mayor asked about the NJ American Water project and when paving would be complete. The Borough Administrator advised that she is meeting with the water company and the contractor to discuss the timeline and status.

- The Mayor inquired about the paving of Rt. 71. The Borough Administrator stated that plans are to pave the road at the end of April or the beginning of May.
- Mark Horowitz stated that there is a new road sign on Ocean Avenue which is impairing the view at the curve at Corlies and Ocean Avenue. Chief Schneider will investigate.
- Mr. Horowitz asked to reconfirm when Route 71 will be paved. The Borough Administrator restated that the paving is scheduled to be done the end of April or the beginning of May.
- Mr. Horowitz stated that he has seen lighted pedestrian crossing signs in other towns. He asked if these types of signs could be considered in Allenhurst. The Mayor stated he will look into it.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 7:45PM. Motion carried.
