PROCLAMATION OF LOCL DISASTER/EMERGENCY

To all citizens and persons with the municipality of the Borough of Allenhurst, New Jersey, and to all departments, divisions and bureaus of the municipal government of the Borough of Allenhurst, New Jersey.

WHEREAS, pursuant to the powers vested in me by Chapter 251 of the Laws of 1942 as amended and supplemented, N.J.S.A. APP A-930 et. Seq.: N.J.S.A. 404-48-1 (6), and ordinances adopted by the Borough of Allenhurst, I have declared that a local disaster/emergency exists within the jurisdiction of the Borough of Allenhurst; and

WHEREAS, the aforesaid laws authorize the promulgation of such orders, rules and regulations, as are necessary to meet the various problems which have or may be presented by such a disaster/emergency; and

WHEREAS, by reason of the COVID-10 virus pandemic conditions which presently exist in certain areas in, or around, the Borough of Allenhurst which may affect the health, safety and welfare of the people of the Borough of Allenhurst, and

WHEREAS, it has been determined that these areas in/around the Borough of Allenhurst

should be then declared disaster areas, and further that certain measures must be taken to insure that the authorities will be unhampered in their efforts to maintain law and order as well as an orderly flow of traffic and further protect the persons and property of the residents affected by the conditions; and WHEREAS, the following areas: the entire Borough of Allenhurst is designated as a disaster area;

Now, THEREFORE , IN ACCORDANCE WITH the aforesaid laws, we do hereby promulgate and declare the following regulations:

restricted business hours, restricted business practices, restricted driving hours, hours of curfew

shall be in addition to all other laws of the State of New Jersey and of the Borough of Allenhurst until such time as the conditions improve and this proclamation is rescinded.



ORDINANCES – FIRST READING

ORDINANCE #2020-05 CALENDAR YEAR 2020 MODEL ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and

the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Board of Commissioners of the Borough of Allenhurst in the County of Monmouth finds it advisable and necessary to increase its CY 2020 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Board of Commissioners hereby determines that a 1.0% increase in the budget for said year, amounting to \$47,167.54 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Board of Commissioners hereby determines that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Board of Commissioners of the Borough of Allenhurst, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2020 budget year, the final appropriations of the Borough of Allenhurst shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 1.0%, amounting to \$47,167.54 and that the CY 2020 municipal budget for the Borough of Allenhurst be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption; and,

BE IT FURTHER ORDAINED, that the provisions of this Ordinance are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of this ordinance shall stand notwithstanding the invalidity of any part; and,

BE IT FURTHER ORDAINED, that the Ordinance shall take effect after publication and adoption according to law.

ITEMS TO DISCUSS

The Mayor stated that meetings via teleconference, or video conference, could be the norm for the foreseeable future. He thanked the public for their patience, and asked for continued patience as we collectively navigate the best way to conduct Borough Business during the COVID-19 Pandemic.

The Mayor stated that he attended a First Aid meeting this past week. One thing he wants residents to be aware of is that if you call 911, the dispatcher will ask questions regarding symptoms you are experiencing. Please do not take offense. This will be standard practice and the EMS workers and just want to be sure they have enough information to understand the situation into which they are entering.

Comm. McLoughlin thanked Chief Schneider for closing down the parks. Comm. McLoughlin stated that the Boardwalk and beach are to remain open for the present. Signs have been placed on beach and boardwalk to remind people to social distance and not to congregate. Police will disperse any crowds and all must social distance.

Mayor McLaughlin stated that he has noticed groups gathering on porches in town. The Mayor cautioned that during this time of social distancing only people in your household should be on your porch or in your home. If you go anywhere outside of your home you should be maintaining proper social distance. Everything is fluid. The testing center just opened at the PNC Arts Center so numbers of cases in NJ reported will increase, and that is expected. The Mayor is preparing a letter regarding the crisis to send to residents.

The Mayor asked Chief Schneider if the police could do a resident "wellness check" for anyone that they are aware that lives alone, or is otherwise at risk, on a weekly basis. Chief Schneider stated that it was doable.

Chief Schneider confirmed that beach will be open as long as proper distancing happens. He noted that that there are currently no cases of COVID-19 reported in Allenhurst. The Chief stated that he is the Allenhurst Point of Contact for the Board of Health. As such, the Board of Health is required to advise him immediately, should there be any cases in Allenhurst. The town is working hard to stay on top of having proper Personal Protective Equipment(PPE) for officers. Chief Schneider is working with County OEM. He reiterated that the EMS questions are standard- and police use them as well – just to know what situations they are walking into. These precautions must be taken so the Police, and first aid and fire, can stay at full availability

The Mayor asked Chief Schneider what was the protocol if you become ill with COVID-19 regarding who contacts other people you may have exposed. The Chief advised that in the event of a Presumptive positive case of COVID-19, the Health Department notifies the town. The Health Department does the background checking and the contacting of those potentially exposed. The Chief advised that he is on a daily conference call with State and other OEMs where they are fielding many questions. Concerns about HIPA and the noticing if a case is in your town was one issue and how to handle any necessary contact. These and other questions are covered as they come up. The desire is to have procedures beforehand as much as possible.

The Mayor asked Chief Schneider if the curfew could be enforced. The Chief advised that currently consequences of defying the Governor's order on the curfew are not being enforced – with the hope that people comply voluntarily. But, he stated, consequences could possibly be enforced in the future if voluntary compliance does not occur. The Chief noted a somewhat similar situation where the Police Department did issue summonses based on a Governor's executive order regarding lawn watering during a drought. If the curfew were enforced, there could be \$1000 fines and/or community service. He also noted that there have been examples in our county of people sneezing and saying they have virus – these people have been charged with False Public Alarm.

The Borough Administrator stated that Municipal offices are posting on the website anything that is received regarding the pandemic. She asks that residents check the website for these updates and for other information about future meetings and their formats. She advised Borough Hall is closed to the public, but all is still operational and personnel can be reached at 732-531-2757 during regular business hours or via email as listed on Borough Website.

The Mayor stated that the mantra from the Governor is to keep services going, but things change all the time. There are possibilities that bulk pickup or other things could be cancelled. He asks that residents please check phones and emails to keep up on E-blasts and Code Reds and other important updates – and to stay safe.

PUBLIC COMMENTS

James Cummings, of 45 Ocean, asked about the President's Coronavirus Task Force Update and the statement that people who leave NY to reside in another locations during this pandemic should self-quarantine for 14 days. Mr. Cummings stated that we are starting see people move into summer homes from NY in Allenhurst. The Mayor advised that he will talk to county and bring up the concerns and ask for direction on whether this can be enforced. However, in the absence of an executive order, it may not be enforceable. Mr. Cummings understood.

The Mayor asked residents to please call the borough or email the Board of Commissioners with any questions. He also advised residents to call Police, Fire and First Aid with any questions or with emergencies.

Richie Heitmeuler advised that Fire Department's Easter Egg breakfast has been cancelled. And the Borough Administrator advised that Easter Egg Hunt has been cancelled, as well.

There being no further business or comments, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting move to executive session at 7:45PM. Motion carried.

After reconvening, Commissioner McLoughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 8:15pm. Motion carried.
