#### ORDINANCE #2020-16 AN ORDINANCE REVISING THE BOROUGH CODE OF THE BOROUGH OF ALLENHURST, CHAPTER XXVI SUBSECTION 3-2 ENTITLED ZONING MAP

**WHEREAS,** the Borough Council of the Borough of Allenhurst has determined that it is in the best interests of the community to revise a portion of its existing Borough Code concerning the Development Regulations, section 26.3-2, to provide an updated Zoning Map;

**NOW THEREFORE, BE IT ORDAINED** by the Borough of Allenhurst, County of Monmouth, State of New Jersey, that the Borough Code of the Borough of Allenhurst be and is hereby amended and supplemented as follows:

**I.** Chapter XXVI be and is hereby revised to delete the existing subsection 26-3-2 entitled Zoning Map and replace it with the following:

26-3-2 The boundaries of each of the districts are established as shown on the map entitled "Borough Zoning Map" prepared by Leon S. Avakian, Inc. Dated August 26, 2020 which accompanies and is hereby made a part of this chapter. The Zoning Map referred to herein can be found on file in the office of the Borough Clerk.

#### And, it is further

**ORDAINED** that except as herein above provided, the remainder of Chapter XXVI entitled ADevelopment Regulations shall remain unaltered and in full force and effect; and it is further

**ORDAINED** that the provisions of these ordinances are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of these ordinances shall stand notwithstanding the invalidity of any part; and it is further

**ORDAINED**, That this Ordinance shall take effect after publication and adoption according to law.

## A RESOLUTION TO ADOPT STANDARD PROCEDURES AND REQUIREMENT FOR PUBLIC COMMENT DURING REMOTE PUBLIC MEETINS HELD DURING A DECLARED EMERGENCY

Offered By: Comm. McLoughlin Seconded By: Comm. Bolan

**WHEREAS,** there is currently a public health crisis associated with the COVID-19 pandemic; and

**WHEREAS,** the COVID-19 pandemic has forced local government entities throughout New Jersey to hold public meetings remotely; and

**WHEREAS**, the Director of the Division of Local Government Services, pursuant to Section 8 of the newly enacted P.L. 2020 c. 34, promulgated emergency regulations codified in N.J.A.C. 5:39-1.1 through 1.7 to ensure continuity of government operations and transparency in conducting public business when an emergency requires a governing body meeting to be held remotely; and

**WHEREAS**, the Borough of Allenhurst, in an effort to take any and every necessary precaution to ensure the safety of its residents, and in an effort to abide by the Director of the Division of Local Government Services' emergency regulation, has elected to continue the use of remote public meetings; and

**WHEREAS**, in accordance with the provision set forth in J.J.Z.C. 5:39-1.4(h), the Borough is adopting the following standard procedures and requirement for public comment during remote meetings:

- 1. The Borough shall facilitate a dialogue with the commenter to the extent permitted by the electronic communications technology.
- 2. The Borough shall facilitate said dialogue through ZOOM and/or telephone conference via a webinar link and a call-in number to be provided on the Borough Public Notice in compliance with the Open public meetings Act.
- 3. The Borough shall allow members of the public to make public comment by audio or by audio and video.
- 4. The Borough shall permit members of the public to submit public comments by electronic mail and in written letter form to the Borough Clerk up to 3 days prior to the schedule remote public meetings.
- 5. Public comments submitted through electronic mail or written letter before the public meetings in question, within the deadline addressed in sub-paragraph 4, shall be read aloud and addressed during the remote public meetings in a manner audible to all meeting participants and the public listening.
- 6. The governing body may, in its discretion, elect to summarize duplicate comments, however the governing body must not summarize certain duplicative comments while reading other duplicate comments individually.
- 7. The governing body may require members of the public to state whether they wish to speak and to identify themselves prior to speaking.
- 8. The procedures and requirements for making public comment, along with an explanation of the audio muting function of the communication technology being used, shall be announced at the beginning of the remote meeting.
- 9. Any presentations or documents that would otherwise be viewed or made available to members of the public physically attending a governing body meeting shall be made visible on a video broadcast of the remote public meeting or made available on the Internet website or webpage of the entity governed by the governing body.
- 10. If a document would be made available to individual members of the public in hard copy while physically attending the meeting, the document shall be made available in advance of the meeting for download through an internet link appearing either on the meeting notice, or near the posting go the meeting notice both on the website and at the building where the meeting would otherwise be held.
- 11. If a member of the public becomes disruptive during a remote public meeting, including during any period for public comment, the member of the local public body charged with running the remote public meeting shall mute or continue muting, or direct appropriate staff to mute or continue muting, the disruptive member of the public and warn that

continue disruption may result in their being prevented from speaking during the remote public meetings or removed from the remove public meeting. Disruptive conduct include sustained inappropriate behaviors such as, but not necessarily limited to, shouting, interruption, and use of profanity.

12. A member of the public who continues to act in a disruptive manner after receiving an initial warning may be muted while other members of the public are allowed to proceed with their questions and comments. If time permits, the disruptive individual shall be allowed to speak after all other members of the public have been given the opportunity to make comment. Should the person remain disruptive, the individual may be muted or kept on mute for the remainder of the remove public meeting or removed from the remote public meeting.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Board of Commissioners of the Borough of Allenhurst, that the Borough of Allenhurst in accordance with the provision set forth in N.J.A.C 5:39-1.4(h), are adopting the standard procedures and requirements for public comment during remote meetings set forth herein.

**WHEREAS**, The United States Department of Housing and Urban Development has allocated funding to the County of Monmouth for Fiscal Year 2020; and,

**WHEREAS**, The County is making some of these funds available to certain participating municipalities and non-profit agencies; and,

**WHEREAS**, It is required that the Borough of Allenhurst execute a Project Agreement with Monmouth County to undertake a project known as Borough Hall Handicap Handicap Access Improvements; and,

**WHERES**, The U.S. Department of Housing and Urban Development is requiring that the Mayor of the Borough of Allenhurst sign additional certification in order to receive these funds; and,

**WHEREAS**, The Borough of Allenhurst has adopted a policy prohibiting the use of excessive force by its law enforcement agency (police force) within its jurisdiction against any

individuals engaged in non-violent civil rights demonstration; and,

WHEREAS, A copy of that policy is attached to and made a part of this resolution;

**NOW, THREFORE, BE IT RESOLVED**, That the Borough of Allenhurst has met the conditions of receiving a Fiscal Year 2020 allocation by adopting a policy prohibiting the use of excessive force and by not using federal funds for lobbying or by disclosing that funds have been used for lobbying; and,

**BE IT FURTHER RESOLVED**, That the Mayor of the Borough of Allenhurst is hereby authorized to sign the attached certifications which will become part of the Fiscal Year 2020 Project Agreement.

**WHEREAS,** The Commissioners are of the opinion that it is necessary for the protection of property and the citizens of the Borough of Allenhurst that regulations and restrictions be imposed during the Halloween period, in order to prevent vandalism and to preserve law and order in the Borough of Allenhurst during said period of time;

**NOW, THEREFORE, BE IT RESOLVED, AND PROCLAIMED** By the Board of Commissioners of the Borough of Allenhurst as follows:

I. That no persons under the age of 18 years shall be permitted in any public place, public street, or public property in the Borough of Allenhurst between the hours of 8:00 P.M. and 6:00 A.M., prevailing time, on each and every day during the period from October 30 through October 31, 2020, inclusive, unless such person shall, during said hours, be returning from work, night school, fraternity, church, social or school meeting, or enroute to and returning from a physician's office or dentist's office where treatment is to be rendered or has been rendered by such physician or dentist, or is accompanied by his or her guardian or parent over the age of 18 years.

That during said hours and days, no person shall wear any appliance for the purpose of covering any portion of his or her face, or partial mask, in any public place, public street or public property in the Borough of Allenhurst.

II. That all persons, regardless of age, excepting those who are attending minor children, who shall participate in the traditional Halloween activity of "Trick or Treat", within the Borough of Allenhurst on October 31, 2020, shall be in costume, and, shall curtail all "Trick or Treat" activities by 8:00 PM on this date.

That any person who is a parent, guardian or standing in loco parents of any person under the age of 18 years who permits, consents or allows any person under the age of 18 years to violate the provisions of this resolution of any part thereof, shall likewise be guilty of a violation of this resolution.

That any person who shall violate this resolution shall be subject upon conviction to a fine not exceeding \$200.00 or imprisonment of not more than 30 days, or both, in the discretion of the Municipal Court of the Borough of Allenhurst.

This resolution and proclamation shall take effect immediately upon adoption and approval according to law.

**WHEREAS**, the stigma associated with the disease of mental illness is identified as the primary reason individuals fail to seek the help they need to recover from the disease, and;

**WHEREAS,** Stigma-Free Communities aim to inspire public interest and open dialogues about stigma, raise awareness of the disease of mental illness and substance use disorder and create a culture wherein residents who have the disease of mental illness and/or substance use feel supported by their community and neighbors and feel free to seek treatment for the disease without fear of stigma and;

**WHEREAS**, promoting awareness that there can be no "health" without mental health will break down barriers and encourage residents of all ages to be mindful of their mental health and ask for help when needed, and;

**WHEREAS**, local resources are available to treat the diseases of mental illness and substance use disorder so no one resident needs to suffer alone or feel hopeless, and;

**WHEREAS,** establishing Stigma-Free Communities will raise awareness of resources, inclusive language, and encourage residents to engage in care as soon as the need is identified so recovery can begin, hope is inspired and tragedies are avoided, and;

**NOW THEREFORE BE IT RESOLVED** that Borough of Allenhurst recognizes the community needs and supports the efforts of the County of Monmouth in designating Allenhurst as a Stigma-Free Community.
