PUBLIC HEARING

Mayor McLaughlin discussed painting the Borough's water tower. He stated he would like to get an estimate on determining its structural integrity and then an estimate for painting.

Cathy Caulfield, 215 Cedar Avenue, asked about the lifeguard station. Mayor McLaughlin explained that Takanassee is trying to get rid of two of the stations and the Borough was interested in acquiring one. He stated there are problems, however, because the stations are not on an historic register and they may be costs associated which will make it prohibitive. If the Borough did acquire it, they would use it for a museum, and perhaps a community center.

Mrs. Caulfield stated it would be very expensive to renovate. They should use that money to refurbish the tennis courts.

John Zazzarino, Loch Arbour Board of Trustees President, talked about Bradley Cove and putting in a station there. The County would like to see a resolution from the Borough.

President Zazzarino stated he sent a letter to the Mayor a couple of weeks ago. There has been talk in the Village about starting up the Sparsely Populated Communities clock again. He wanted to know how the Commissioners felt about it.

Mayor McLaughlin stated that Paul has called him and he understands why he wants to do it. They can't do anything until they get answers from the State. He doesn't know what the point would be to do it before then. The subcommittee is meeting on December 6th. They should wait for that at least.

President Zazzarino stated there should be a timeline on when they are going to the State with their questions.

Mayor McLaughlin commented that even when they have those answers, they have to determine how this is a good deal for both towns. There is a lot of animosity over losing the police contract.

Comm. McLoughlin stated he would like to hear what the Committee says. Once they have the answers, they should hold public hearings.

President Zazzarino talked about having the State help them with expenses and possibly hiring a consultant.

Comm. McLoughlin thought it was a great idea.

Mayor McLaughlin suggesting waiting until after the December 6th meeting and see what the sub-committee has to say.

President Zazzarino asked for a letter regarding a timeline and Comm. Bolan stated they should see what the subcommittee suggests.

Adele Gannon, 318 Allen Avenue, stated as far as Princeton and Princeton Boroughs' merger, there was nothing about education. Comm. Bolan stated both towns used the same school system. Mrs. Gannon stated the State wants small towns to merge, perhaps they can offer an incentive as far as the education part of it goes.

Comm. Bolan added that there is also a question on whether students who are in their last year in Ocean will be allowed to graduate from Ocean and who would pay.

Dennis Sternberg, One Cedar Avenue, spoke against the lifeguard station. He stated it is just an old wood building. It is obsolete and has no historic value. It will do no good for Allenhurst. It is a big mistake to even consider it.

Dr. Sternberg stated if money is being spent at the Club, it would be nice to see new roofs on the cabanas and to fix up the little shed there the lifeguard stuff is kept. He asked if the north end of the boardwalk was going to be replaced.

Mayor McLaughlin stated they will continue to replace the boardwalk going north. They may get another 1/3 of it done this year.

Dr. Sternberg told the Commissioners they were doing a great job with the town.

Dr. Sternberg then told the Commissioners that he would be extremely wary of any promises from the State unless they were written in stone. There are mini municipal megalomaniacs in many small towns. These Commissions are not. Once done, it cannot be undone.

Mrs. Gannon asked if there were any new businesses in town and Mayor McLaughlin stated a new energy trading company is opening next to Allenhurst Car Care. He has also hear about a health

shop by the dance studio, but has no direct information on that.

Dr. Sternberg asked about putting in a sign saying, "Allenhurst Substation' by the JCP&L lot to discourage speeders coming in from town on Main Street.

Mayor McLaughlin stated it was a good idea. He has seen cruisers parked on the "S" curve on Ocean Avenue to deter speeders. He will talk to the Chief.

Doug Caron, Public Works Superintendent, spoke to the Board concerning Beach Club issues. He discussed the repairs that must be made to the wellpoints, a new security system and resurfacing of the pools.

After some discussion on Beach Club issues, and there being no further comments or discussion, Comm. Bolan moved, seconded by Comm. McLoughlin, that the meeting be adjourned. Motion carried.
