A RESOLUITION TO APPROVWE CONTRACT WITH VNA FOR NURSING SERVICES

WHEREAS, There exists a need for Public Health Services in the Borough of Allenhurst; and, WHEREAS, The Borough Administrator has certified in writing that the value of the acquisitions will not exceed \$17,500; and,

WHEREAS, This appointment is being made without competitive bidding because the appointment involves a member of a recognized profession, licensed and regulated by law, pursuant to NJSA 40A:11-5;

RESOLUTION #9

A RESOLUTION TO ESTABLISH A YEAR END PENALTY OF SIX (6%) PERCENT TO BE CHARGED ON DECEMBER 31 OF EACH YEAR ON DELINQUENCIES IN EXCESS OF \$10,000

Offered By: Comm. McLoughlin Seconded By: Comm. Bolan

WHEREAS, NJSA 54:4-67 permits the governing body of each municipality to fix the rate of interest to be charged for non-payment of taxes or assessments subject to any abatement of discount for the late payment of taxes as provided by law; and,

WHEREAS, NJSA 54:4-67 permits the governing body to fix a penalty of 6% to be charged to a taxpayer with a delinquency in excess of \$10,000.00 who fails to pay that delinquency prior to the end of the fiscal year. The penalty so fixed shall not exceed 6% of the amount of the delinquency with respect to each most recent fiscal year only;

NOW, THEREFORE, BE IT RESOLVED, By the Board of Commissioners of the Borough of Allenhurst that the Tax Collector has the authority to fix a 6% year end penalty to all delinquencies in excess of \$10,000.00 that have not been paid prior to the end of the fiscal year and to become effective immediately.

RESOLUTION #10

A RESOLUTION ESTABLISHING A YEAR END PENALTY OF SIX (6%) PERCENT TO BE CHARGED ON THIRD PARTY LIENS ON DECEMBER 31 OF EACH YEAR WHEN THE AMOUNT PAID BY THE LIEN HOLDER IS IN EXCESS OF \$10,000.00

Offered By: Comm. McLoughlin Seconded By: Comm. Bolan

WHEREAS, NJSA 54:4-67 permits the governing body of each municipality to fix the rate of interest to be charged for non-payment of taxes or assessments subject to any abatement of discount for the late payment of taxes as provided by law; and,

WHEREAS, NJSA 54:4-67 has been amended to permit the fixing of said rate of 8% per annum on the first \$1,500.00 of the delinquency and 18% per annum on any amount in excess of \$1,500.00 and allows an additional penalty of 6% to be collected against a delinquency in excess of \$10,000.00 on property that fails to pay the delinquency prior to the end of the calendar year; and,

WHEREAS, NJSA 54:4-67 permits the governing body to fix a penalty of 6% to be charged to a taxpayer with a delinquency in excess of \$10,000.00 who fails to pay that delinquency prior to the end of the fiscal year. If any fiscal year delinquency in excess of \$10,000.00 is paid by the third party lien holder of an outstanding tax sale certificate, the holder or purchaser shall be entitled to receive the amount of the penalty as part of the amount required to redeem such certificate of sale providing the payment is made by the tax lien holder prior to the end of the fiscal year. If the holder of the outstanding tax sale certificate does not make the payment in full prior to the end of the fiscal year, then the holder or purchaser shall be entitled to a pro rata share of the delinquency penalty upon redemption and the balance of the penalty shall inure to the benefit of the municipality. The penalty so fixed shall not exceed 6% of the amount of the delinquency with respect to each most recent fiscal year only;

NOW, THEREFORE, BE IT RESOLVED, By the Board of Commissioners of the Borough of Allenhurst, that the Tax Collector has the authority to fix a 6% year end penalty to all third party tax sale certificates in excess of \$10,000.00 that have been paid in full by the lien holder prior to the end of the fiscal year and if not paid in full, the lien holder shall be entitled to a pro rata share of the

delinquency penalty upon redemption and the balance of the penalty shall be inure to the benefit of the municipality for the 2012 tax year and to become effective immediately.

OTHER BUSINESS

Mayor McLaughlin spoke to Robert Simmen, III, Code Enforcement Officer, regarding violations. He asked about the house on Cedar Avenue and Mr. Simmen stated there is a warrant for the homeowner's arrest. There is nothing he can do until he shows in court. He explained the procedure to the Commissioners.

Mayor McLaughlin felt the homeowner should keep getting violations.

Mayor McLaughlin asked about the lot on Main Street and Mr. Simmen explained that he got tickets and was supposed to clean it up, but hasn't.

Doug Caron, Public Works Superintendent, explained that most of it is brush. He fills 5 to 6 barrels every day. He took about three dumpster's worth out, but then he heard the property owner ran out of money.

Mr. Simmen said the property owner told the Judge that he was working on getting the lot cleaned up.

Mayor McLaughlin stated he would like violators to get a verbal warning and in two weeks a written warning and after another week a summons should be issued. If the violation is still not abated, separate tickets should be issued. He would like the owner to become uncomfortable.

Mr. Simmen stated he can write separate violations, but the Judge is likely to dismiss all but one or two.

Comm. Bolan stated the judgment from the court can become a lien against the property. They can create a record. They will even write a letter to the court if desired.

Mayor McLaughlin stated tall grass should be easy. They should get a letter and a violation within two days. Repeat violators should get ticket after ticket. It should be a thorn in their side.

Comm. McLoughlin stated his concern is why things have to come from the Board of Commissioners. Why did it take so long to get anything done?

Mr. Simmen explaikns that he comes in about two to three times a week in the mornings. He makes appointments for C/O's and fire inspections at the resident's request.

Mayor McLaughlin stated they are looking for a more regimented process.

Comm. Bolan suggested that everything be put in writing.

Lori Osborn, Borough Administrator, stated they spoke about a weekly report.

Doug Caron spoke about the Beach Club, stating he wants to get some work done. They have already taken the bocce court out and the garden is gone. He would like to move the fence forward. They would be able to get another 35 to 30 lounges there. He has gotten prices. To continue the black fence would be \$11,845.00. This will cover 102' with a sliding gate, instead of a gate that opens out. The Board can decide to leave the current fence and paint it black. He enumerated the improvements he would like to make as follows:

- 1. 330' feet of boardwalk to be replaced will cost about \$24,000.
- 2. Fence will cost about \$12,000.
- 3. Pump room valves need to be replaced at \$3,000.
- 4. Cabana door replacements will be about \$14,000.

The Board agreed to all improvements, including the new wrought iron fence.
