### **ITEMS FOR DISCUSSION:**

The Mayor congratulated Comm. Cumiskey on his election to the Board of Commissioners in the General Election of November 9th.

The Police Chief discussed information that has been gathered regarding pursuing dispatch services with Monmouth County. Rice notices were sent to all current dispatchers. A letter, dated 11-29-22, was received from the employees indicating their request that discussion regarding their terms and conditions of employment as referenced in the Rice notice be held during an open meeting.

The Chief advised that estimated savings of pursuing county dispatch, as compared to the infrastructure investments and related costs of updating our current system, would be over \$100,000. The Chief also advised that the County equipment is far superior to what could be done in house. He stated that the county has indicated they would provide current Allenhurst dispatch employees the opportunity to interview for positions at the county. The Chief will obtain a formal proposal as the next step.

The Mayor thanked the DPW Superintendent for the wonderful holiday decorations that are going up around town and for his attention to the trees in town that required removal.
