## BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF ALLENHURST, COUNTY OF MONMOUTH, AS FOLLOWS:

**SECTION I.** That Ordinance No.: 2022-01 entitled "An ordinance fixing the salaries of all appointed officials and employees of the Borough of Allenhurst in the County of Monmouth and State of New Jersey (excepting members of the police department)" be and is hereby revised and amended to read as follows:

Section 1.

B. A clothing and maintenance allowance in the amount of \$375.00 annually shall be provided to all full-time Communication Officers. Said allowance shall be paid bi-annually on June 15<sup>th</sup> and December 15<sup>th</sup> and shall be pro-rated accordingly.

### ORDINANCE 2023-02 AN ORDINANCE REVISING THE HANDICAPPED PARKING ORDINANCE OF THE BOROUGH OF ALLENHURST. Offered By: Mayor McLaughlin Seconded By: Comm. McLoughlin

WHEREAS the Borough Council of the Borough of Allenhurst has determined that

WHEREAS, the Borough Council of the Borough of Allenhurst has determined that the Handicapped Parking Ordinance, Section 7-39, needs to be revised; and

**WHEREAS,** the Borough Council of the Borough of Allenhurst has determined it is in the best interests of the community to revise the Handicapped Parking Ordinance to add an additional dedicated space;

**NOW THEREFORE, BE IT ORDAINED** by the Borough of Allenhurst, County of Monmouth, State of New Jersey, that the Borough Code of the Borough of Allenhurst be and is hereby amended and supplemented as follows:

I. That Chapter VII, section 17-39 of the Borough of Allenhurst Revised General Ordinances be and is hereby revised to add a newly dedicated handicapped parking space along Main Street as follows:

Street	Side	No. of Spaces	Location
Main Street	Westerly	1	Along the Westerly side line directly in front of 535 Main Street.

**II. REPEALER**. All other sections and subsections of Borough Code of the Borough of Allenhurst not specifically amended by this Ordinance, shall remain in full force and effect.

**III. INCONSISTENT ORDINANCES.** All other Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistency.

**IV. SEVERABILITY**. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

V. AND IT IS FURTHER ORDAINED that this Ordinance shall take effect twenty (20) days after the first publication thereof after final passage as provided by law.

## **ITEMS FOR DISCUSSION:**

The Mayor announced that the Bolan and Selden Families in honor of Commissioner Bolan, through the Jersey Shore Running Club, will hold a race in town on 6/24/23. This race will be for the benefit of the Allenhurst Fire and First Aid Departments as well as the parks.

Comm. Cumiskey asked to discuss the status of the decision for Dispatch Services as the communications issues that the Fire/EMS/Police are dealing with must be resolved.

The Chief of Police stated that he is on board with using the County for Dispatch. He stated that he would have loved to keep our own dispatch, but staffing has become impossible to manage and the technology available with the County is far superior to anything Allenhurst could do inhouse. He also stated that the most recent time estimate for obtaining the necessary infrastructure changes to keep the Dispatch in-house is upwards to a year or more, whereas the county can have the town up and running within a month and a half of when an agreement is approved.

The Chief has received a quote from the County, but will go back to see if the figure can be negotiated. The commissioners also confirmed that the Police Department would continue to be staffed from 9-5 during the week, and also on weekends in the summer from Memorial Day to Labor Day.

Comm. Cumiskey asked for a status on the repairs to the Boardwalk. The DPW Superintendent stated that repairing the desired 1/3<sup>rd</sup> of the boardwalk utilizing Allenhurst Personnel would take 4 to 5 weeks. If that repair is to be done this year, they should begin ASAP.

The Mayor asked the Borough Attorney to prepare Requests for Proposals (RFP"s) for both a Sundry Shack at the Beach Club and a potential food truck.

Comm. McLoughlin discussed reintroducing revisions to the Hedge Ordinance. The commissioners are going to review and then send out an email explaining the revisions when introduced. The ordinance would not apply to hedges already in place, only for landscaping going forward.

# PUBLIC COMMENTS

Resident, Aris Papageorge was present and wanted to know more about redevelopment. The Mayor explained the history of the issue and where the town currently stands. He encouraged Mr. Papageorge to attend the February 14 Meeting where the settlement will be discussed.

There being no further business or comments, Comm. Cumiskey moved, seconded by Mayor McLaughlin that the meeting move to executive session at 8:20 PM. Motion carried.

After reconvening, Comm. Cumiskey moved, seconded by Mayor McLaughlin that the meeting be adjourned at 8:40 PM. Motion carried.
