PUBLIC HEARING

Peter Avakian, Borough Engineer, spoke about the pool contractor, stating he is prepared to mobilize after April 1st. It will take approximately three weeks to complete.

Doug Caron, Public Works Supervisor, stated they have sand-blasted the steps and the front of the pool where there is a crack in preparation for the job.

Mr. Avakian stated they built some small repairs into the contract if they are needed.

Tim Moriarty asked if the Board was sure the pumps would work. Mr. Caron stated the pumps are maintained by Pilot Electric and they will work. Their only problem may be with the well points because they only go so far. They should not get the amount of sand they were getting last year as they were able to repair one of the points which had broken. Chris Rogers, Beach Manager, stated Burke is scheduled for Thursday and Friday of next week to re-install the well points.

Mr. Avakian then spoke regarding the Main Street project, stating the concrete and masonry work should be completed by Friday. If there is money left, he would propose scoping the line. Paving will commence on April 16th and should take no more than four days.

Mr. Avakian spoke about the repairs to the ABC restaurant floor. It should take three days and they are planning to start on Monday.

Richie Heitmueller, Allenhurst Fire Department, stated they would like to do Casino Night in conjunction with the member party. Mr. Rogers stated the members' party is scheduled for August 11th. There was a short discussion on the particulars.

Mr. Heitmueller asked whether there was going to be an End of Year party. The Fire Department usually participates with their wheel. If not, they may want to run their wheel over July 4^{th} weekend.

Adele Ganon, 318 Allen Avenue asked how many sales there were in Allenhurst in 2012. She walks every day to St. Mary's church and has noticed water coming out of a pipe on Allen Avenue. Comm. McLoughlin stated his guess would be that it is someone's sump pump. Mrs. Ganon asked if it would be discharging every day. Mr. Avakian stated they had suggested at one point that the property tie into the drainage structure, but it wasn't done. Mr. Caron stated there is an underground stream there and they have water in their basement constantly. They have a drainage system in their basement. Mr. Heitmueller agreed, stating that the fire department has pumped out their basement on several occasions after a rain storm.

Comm. McLoughlin stated the Commissioners adopted a pool ordinance because water tables are so high in Allenhurst. This is why they now require soil borings.

Comm. McLoughlin asked how the new security system was coming and Mr. Caron responded, stating they have added a number of other applications that they will be able to use in the future.

There being no further comments, public hearing was closed and the Board adjourned to caucus. After reconvening, the Board went into a workshop session to discuss the 2012 budget.
