PUBLIC HEARING & BUSINESS OWNERS' DISCUSSION

Mayor McLaughlin stated he asked the business owners here tonight as he has seen empty store fronts. These are difficult times with the economic downturn. They were fortunate enough to have some surplus cash and they have set aside some money for events on Main Street. He asked the business owners how they could help.

Mayor McLaughlin read a letter from Cravings regarding 15 minute parking on the east side of Main Street.

John Reng stated that two hour parking is too long. Maybe one hour is better. Fifteen minutes may not be enough. The problem is merchants parking in front all day. It is a fragile economy and people are not anxious to go into business. He suggested maybe cutting down the amount of paperwork. There has been 50 years of zoning laws that are very restrictive. There was an attempt to broaden them, but it still not very broad. The result is that there is not enough diversity. He stated that it there was a previous discussion on changing the zoning to prohibit first floor professional offices from Corlies Avenue, south. The bank is coming in, which should help. JCP&L does nothing for the town. It is a check cashing operation.

Rose Myers stated she was thrilled to get the new signs for the parking lot. The lot is cleaned up and looks good. However, people who live above the stores park in front of her business for days on end.

Mayor McLaughlin stated he thought the parking was for two hours. Ronnie Dahl, Deputy Borough Clerk stated they have residents stickers and can park there.

Comm. Bolan suggested resident parking be prohibited between Corlies and Allen Avenues.

Marissa Caruso commented that the area between Allen and Corlies Avenue should be all retail.

Mayor McLaughlin spoke about signs, stating that some of the seasonal shops are putting up hand-lettered signs, which look awful. By the time they are warned about them, they are gone for the season. They will be vigilant about the signs. He stated they are also planning to do a run in the summer. They can hold sidewalk sales. The Borough will advertise as a Borough event. Mayor McLaughlin spoke about a trolley or a horse and carriage ride. They can partner with the businesses for something like that.

Mayor McLaughlin continued, stating they will have a bus on weekends and holidays during the summer. They thought about asking the businesses to put advertisements on it. Chris

Rogers presented a sample of a magnetic sign which will adhere to the bus. The signs were about \$100.00 although they may want to do something a little larger. They can also do something more uniform such as color. Mayor McLaughlin stated it is the old school bus. They are trying to think of ways to get the business names out there. They have the bus already and it will run regardless, but he thought the ads would benefit the businesses.

Mayor McLaughlin also suggested an event at the Beach Club highlighting one or two stores at a time.

Ms. Myers asked for help from the town in bringing new businesses in. She asked if the Borough knew of any new businesses. Comm. McLoughlin answered that he doesn't know of any.

Mayor McLaughlin stated that someone asked him about tax breaks for businesses, but the town is just too small to justify that.

Theresa Santoro asked about giving out a liquor license and Comm. McLoughlin stated that the Board can create a license. It was a carrot for the redevelopment zone.

Mr. Reng stated the Spring and Fall is when they need help. Anything the Board can do to help bring in business or generate excitement then would be appreciated.

Ms. Myers stateds that she could use a trolley for her two events. She stated the British car show is on April 17 and the Outdoor Market is May 29th.

Mayor McLaughlin stated it would have to be a Borough-wide thing. Ms. Myers stated she was putting it out there for anyone to piggy-back onto.

Mrs. Dahl suggested music in the park one night. Mayor McLaughlin stated that was a good idea. Tghey also talked about doing a movie in the park.

Mayor McLaughlin stated they are just trying say they want to work with the businesses. Mrs. Caruso stated if they held a sidewalk sale in the summer and the Borough wants to do the advertising, it would be great.

Mr. Reng suggested the Borough put up banner poles; one on each side of Main Street. Businesses, organizations or the Borough could hang banners. They could advertise the run. It will have a lot of visibility. The Borough would control the poles, but the individual would provide the banner.

Comm. Bolan suggested doing the run in the Fall.

Mr. Reng suggested having a dog show for police canines, state-wide. They can perform agility tests, drug tests, beauty test, etc. He stated that NJ Transit runs drills for first responders. They put on mock demonstrations and that may attract some business. He suggested a farmers market north of Corlies.

Mrs. Caruso asked about cutting down the trees on Main Street. When in bloom, you cannot see her window or sign. They are not necessary. The other side of the street looks nicer without the trees.

Theresa Santoro stated she could talk to the Garden Club. They were thinking of re-doing the pots on Main Street.

Comm. Bolan asked if the Borough needed to hire someone to take the trees down and Mr. Caron stated they can do it.

Mr. Reng stated that the planters on the ground are nice, but they become trash receptacles. How about putting them up on the lampposts?

Mr. Caron stated that Red Bank has the pole planters which are wrought iron and match the poles. They lower for maintenance. A truck waters them with a shepherds hook.

Mr. Reng stated that jungle Lasers has a program with buildings and can show what Main Street would look like with different kinds of outdoor furniture. Brookdale also has a program for landscaping and he believes it is free.

Mayor McLaughlin stated they need a point person to decide what everyone wants to do. Mrs. Caruso suggested Rose Myers, who said she would be happy to be the point person, but it is a lot of responsibility. She wishes there was a person or element or plan to attract business. There are ways to pull people in.

Comm. McLoughlin stated they can look to change zoning.

Mrs. Caruso stated that Ronnie at Spellbinders has a Memorial Day tent event. Maybe everyone can get together for that.

Ms. Myers talked about her antique show, stating she will have more vendors, food, etc. There will be thousands of people.

Bernie Costello comments that live music doesn't have to be expensive. They could have roving musicians.

Chris Rogers stated they can try to bring Main Street down to the beach. They have a new deck and boardwalk.

Mrs. Caruso stated she liked the idea of vendor day at the beach.

Kathy King, Central Jersey Bank, stated she would be interested in participating in many of these ideas. They are planning a grand opening in the Fall. She will join any committee that is set up.

David Krenkel stated he would be interested in being a part of a quarterly meeting.

Theresa Trocchia, of Artistic Finds, stated she opened a business next to the bank. It is a little art gallery and studio. She also wanted to join and participate in any way. She added that she was thankful for the police presence in Allenhurst. They have already helped her deal with a situation.

There was a discussion on the proposed merger with Loch Arbour. Mayor McLaughlin explained the procedure.

A Loch Arbour resident stated Loch Arbour is in possession of a letter which states that if a consolidation were to take place, Loch Arbour would cease to exist and the children would go to Asbury Park schools. With the savings the families of those children would receive from their taxes, they can send their children to other schools. Some parents are not happy with Ocean schools.

Comm. Bolan stated that Paul; Fernicola spoke to some of the parents and some of them will accept it. These are the questions which will have to have definitive answers.

William Capik stated that as a resident of Hume Street, he has seen on a first-hand basis what Doug and the guys do.

There being no further comments, public hearing was closed and the meeting adjourned at 9:25 PM.
