WHEREAS, the Borough of Allenhurst, in the County of Monmouth, State of New Jersey (the "Borough") intends to adopt a bond ordinance authorizing funds (\$5,000,000) for capital improvements necessary due to the extraordinary damage to the streets, roads and other public property caused by Super Storm Sandy; and

WHEREAS, the Borough desires to request the waiver of down payment requirement in connection with the adoption of the bond ordinance pursuant to N.J.S.A. 40A:2-11 (c); and

WHEREAS, the Borough Board of Commissioners believes that:

- (a) it is in the public interest to accomplish such purpose;
- (b) such purpose is in compliance with the requirements of N.J.S.A. 40A:2-11 (c) et seq.;
- (c) said purpose or improvements are for the health, welfare, convenience or betterment of the inhabitants of the Borough;
- (d) the amounts to be expended for said purpose or improvements are not unreasonable or exorbitant and are consistent with the requirements of N.J.S.A. 40A:2-11 (c), <u>et seq</u>.; and
- (e) the proposal is an efficient and feasible means of providing services for the needs of the inhabitants of the Borough and will not create an undue financial burden to be placed upon the Borough.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF ALLENHURST, IN THE COUNTY OF MONMOUTH, NEW JERSEY, AS FOLLOWS:

Section 1. PUBLIC HEARING

Mayor McLaughlin stated they are trying to connect the north and south decks. The storm opened a second set of stairs and they will leave those open. The snack bar, however, is in a tough spot. It is very congested and the size of the membership makes it difficult to utilize. They are looking to put in heat and air conditioning and use the building for municipal purposes or for groups such as the Garden Club to utilize in the off-season. In the summer it can be used as a cool-down room. They are still going over some ideas. One of them is to incorporate the snack bar into the restaurant building so that all food is in a centralized spot.

Bob Scally stated that the original stairs used to be twice as wide. Mayor McLaughlin stated they will use one side for coming into the Club and the other for going down out of the Club. This should ease some of the traffic congestion.

Lori Osborn gave the following status report of projects:

CABANAS & PILINGS

Bids are awarded. Work has commenced on pilings. The contract for the cabanas will be signed tomorrow and work will start on those right away.

CABANA AWNINGS

The Commissioners wil make a decision on this.

CABANA BATHROOMS AND PUBLIC BATHROOMS

Bids will be opened on March 7th and awarded on March 12th.

UMBRELLA DECK

Bids awarded.

SNACK BAR/BANDSTAND

Joe Tomaino is working on drawings.

RESTAURANT

Restaurant has been demolished. A subcommittee was just appointed and will come up with ideas for the new construction.

SEA WALL

Bids will be opened on March 7th and awarded on March 12th.

BOARDWALK & RAILINGS

Once SeaWall is repaired, the boardwalk can be repaired.

PUMP ROOM & ELECTRIC SERVICE

We will have an idea on whether there is electric service at the Club and will work on getting service back to the pump room. Peter Avakian's office will plan to restore the pump room as a change order to the sea wall project.

POOL

We have sent Purchase Order to Renosys and will schedule repair in March.

WELL POINTS

Peter Avakian is still investigating the new system. They have some questions as this is not a tried and true system. A new system will require that the pumps be re-configured by Pilot Electric. They are familiar with the new system and know what they have to do. As soon as we know which way we are going, I will contact Burke.

UNDERMINING OF POOL DECK

This is just a small repair and can be done when pump room is done.

HANDRAIL AT THE END OF ALLEN AVENUE

One the seawall is fixed, Doug feels he can handle replacing the rail.

REMOVAL OF SECOND SET OF STAIRS AT CABANAS

The project has been bid with the removal of the stairs. There have been some questions about leaving them. We can leave them, but we will have to build a platform and small enclosure for the electrical shut-off. Once the stairs have been evaluated by the Borough Engineer, the Borough will have a better idea of how to proceed.

Mayor McLaughlin stated they are discussing when the opening date should be.

There was some discussion over insurance matters..

Comm. Bolan stated that some people are freaked out over new cabana rules. He stated they have not made any new rules as yet.

Mayor McLaughlin urged members to call Borough Hall if they hear any rumors. Get the right story. They may not make everyone happy with these rules. It will not be perfect.

Comm. Bolan talked about some ideas they were considering. He stated they do not want people subleasing their cabanas. Maybe they will come up with a jurisdictional limit. Maybe one cabana per residence so that three people who live in one residence don't each have a cabana.

Mayor McLaughlin stated this may stop the children of residents from putting their names on the cabana list.

Comm. Bolan stated they would probably permit cabanas to follow family lineage.

Mayor McLaughlin stated new cabanas will go to tax paying residents in town.

Comm. Bolan stated the goal is to keep the list moving. They do not want to be inequitable.

Mayor McLaughlin stated that any deletions or additions due to clerical error will be resolved by resolution. They can also post the list on-line.

Stephenie Reynolds asked about the out-of-town list. Mayor McLaughlin responded that it is still being maintained. They will not use it until all residents on the list have gotten a cabana.

Mrs. Reynolds asked for an explanation of rates for in-town versus out-of-town members and asked how costs would be equitably distributed.

Mayor McLaughlin stated that they do not know at this point what that answer is. It will have to wait until the projects are done and all insurance and FEMA money has been counted.

Kevin Reynolds asked for a definition of resident and Mayor McLaughlin stated it is someone who lives in town and pays taxes.

Mayor McLaughlin added that people who rent in town are given the opportunity to become members, but if they do not come back the next year, they are dropped from membership.

Mr. Scally stated it looks like Allenhurst will be okay and will be open. Other towns are not so lucky. He then asked about residents who rent year round. Mayor McLaughlin stated they can become members, but they will not be eligible for a cabana. The reason is because it is tax dollars that are being used to rebuild.

Mrs. Reynolds asked if there would still be a limit of 10 people per facility and Mayor McLaughlin stated that they will allow 10 per cabana, but new locker memberships will be capped at eight.

A question was asked as to whether the Board was considering limiting the number of guests or guest books and Mayor McLaughlin stated they were looking at a couple of things as far as guest tickets.

Comm. McLoughlin mentioned that they can track the number of guest books purchased by members and maybe they will look at capping the number of books that can be purchased by facility.

Mayor McLaughlin added that they have also been discussing requiring two tickets on a weekend or holiday.

Mr. Scally asked if there was a way to track whether a resident has claimed a family member is a resident also. Mayor McLaughlin replied that they know this is happening and they have started cracking down on it. Members swear an oath that the information they give is correct. If they find this not to be the case, they can be expelled from the Club. They will check this even more closely for this season.

Michelle Petti asked if the Borough limits the number of daily passes and Mayor McLaughlin stated they can limit the number to 100 persons at a time. They look at the conditions, including surf and overcrowding before they do this.

Mr. Moriarty stated there was talk about re-purposing the snack bar and stated that older folks have trouble getting down the stairs. He asked what would happen in the off-season.

Mayor McLaughlin stated they can use it for town functions or as a rental.

Mr. Reynolds asked if the Commissioners would post a draft of the rules before adoption and Mayor McLaughlin assured him that he would.

Joan McCann asked about the one entrance at the cabanas and Mayor McLaughlin stated that was the plan. There will be no difference in appearance from the boardwalk. They are still not 100% sure with the stairs. He also talked about the bathrooms, stating the idea is to have a bathroom for the public and one for the members. The public bathroom will face north.

Mrs. Reynolds asked if the drawings for the cabanas could be put on the website and Mayor McLaughlin said he would do that.

Mrs. Reynolds stated that since there is an anticipation of an increase in volume, will the Commissioners have another lifeguard area. Mayor McLaughlin stated he would leave that up to the lifeguard captain.

There being no further comments, the meeting adjourned to caucus.

After reconvening, the board discussed possibly purchasing a jitney next year and one the year after. The board discussed the opening date for the Club. Mayor McLaughlin suggested opening on Memorial Day weekend and then not opening until the middle of June. Doug Caron, Public Works Supervisor, stated he thought it would be better to put off the opening until the middle of June.

There was some discussion on starting a program whereby people would donate board for the boardwalk.

There was a short discussion regarding the roof over the pump room. Doug stated it was plywood and public works could fix it.

There was some discussion regarding putting up plywood walls while the restaurant is being reconstructed.

There was a short discussion on benches for the boardwalk and perhaps starting a program where someone could sponsor a bench for a five year period.

There being no further comments, Comm. McLoughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 9:32 PM. Motion carried.
