## **OTHER BUSINESS**

#### <u>Ordinance 2013-05</u>

Mayor McLaughlin stated he had re-considered some of the changes they made in guest books and he would like to re-visit the issue.

After some discussion the Commissioners decided to amend the ordinance to charge two guest tickets on the weekends of Father's Day, July 4<sup>th</sup> and Labor Day until 3 PM. After 3 PM, only one guest ticket will be charged. The Commissioners also decided not to sell single tickets. An ordinance reflecting these changes will be introduced at the next meeting.

# Restaurant Lease

There was a discussion on costs and on what was needed to make a functional restaurant this season.

Doug Caron, Public Works Supervisor, stated he spoke to Karen and Chic. They need an area away from the tent for the cooking equipment. He has a structure that they can rent for \$150 a month that will do the job.

Since Ms. Marzulli and Mr. Perroto were in the audience, Comm. McLoughlin suggested that they go into legal/contractual caucus to discuss rent. The following resolution was seconded by Mayor McLaughlin:

WHEREAS, State law permits the exclusion of public in certain circumstances; and, WHEREAS, The Board of Commissioners of the Borough of Allenhurst finds that such circumstances currently exist; and,

**WHEREAS,** The Board of Commissioners will make public, minutes of the closed session when confidentiality no longer exists;

**NOW, THEREFORE, BE IT RESOLVED,** By the Board of Commissioners that they are hereby authorized to enter into closed session to discuss legal/contractual matters which are exempt from the public meeting under the Sunshine Law.

# Cabana Rules

Comm. McLoughlin stated he came up with some rules he thought the Commissioners should adopt.

Mayor McLaughlin stated he received a few e-mail suggestions, but opinions were split down the middle.

After some discussion, Mayor McLaughlin stated he was not in favor of, "you move, you lose". Any open cabanas should go to residents. There should be one cabana per household and the principal must be a taxpayer. A child taking a cabana from a parent must be a taxpayer.

Comm. McLoughlin felt the list needed to be cleaned up.

Comm. Bolan stated they have decided some basic issues. He stated he prepared rules also, only his rules are more general. A member can speak to the Commissioners regarding any exceptional circumstances on a case by case basis.

Mayor McLaughlin stated he likes that if a member feels they have a compelling reason, they can come to the Board.

Ms. Osborn stated she will forward the rules to each cabana member along with the cabana agreement.

Mayor McLaughlin explained to the audience the Commissioners' attempt to put the rules in writing and clear up some cloudy issues. They are trying to be more transparent. They will adopt the cabana list by resolution and any changes made to that list will be by resolution. He stated many people believe the cabanas belong to them. They do not. They are Borough property. They are starting with a clean slate and it is time for the rules to be set.

## **Sidewalks**

There was some discussion regarding sidewalks, including properties that had extensive damage to sidewalks when trees fell during the storm.

Comm. Bolan stated the law is quirky regarding sidewalks. The Borough has no liability unless they cause a dangerous condition. He suggested writing a letter asking the homeowners to repair the sidewalks.

Comm. McLoughlin asked that the Code Enforcement Official identify those homes where the sidewalks are in bad shape.

Comm. Bolan stated he has a problem with vegetation from trees or bushes impeding sidewalks. He asked that yellow ribbon be placed around those obstructions and the homeowners notified to trim back their trees and bushes.

#### **Fences**

Ms. Osborn and Chris Rogers asked for clarification of the new fence ordinance. The ordinance does not address height beyond the front of the house. There have been questions on how high a hedge can be placed across the front of the yard, but beyond the front of the house.

After some discussion, the Commissioners instructed Ms. Osborn to bring the matter to the attention of the Planning Board.

# STATUS REPORT ON HURRICANE RESTORATION PROJECTS

Peter Avakian, Borough Engineer, presented the following status report on projects being undertaken in the recovery of Superstorm Sandy:

# **Cabana Piles and Umbrella Deck**

The Cabana piles and Umbrella Deck are complete. Contractor installed additional 12" x 12" pile caps to raise the bathroom floor to above Advisory Base

Flood Elevation (15 feet above mean sea level). Contractor will complete entire project this week with the installation and repair of the handicap ramp railing.

# **Seawall Repair**

Burke Construction has completed construction of the seawall repair and backfill behind the repaired seawall. We are evaluating some wall cracking for additional repair and injection grouting.

#### Cabanas

Joseph Tomaino, AIA Consulting Architect is handling the coordination of this project.

Kelly Builders has installed all of the new cabanas. The Borough beach manager is currently working with Burke Construction to push sand into the area beneath the proposed cabana boardwalk to eliminate the possibility of settlement along the easterly edge of the cabana boardwalk.

#### **Cabana and Public Bathrooms**

As indicated above the cabana pile project, the Contractor has installed additional 12" x 12" pile caps to raise the bathroom floor to above the AFBE elevation 15. Ramps were designed to accommodate this design elevation change.

Work has commenced on the construction of the cabana and public bathrooms.

#### **Street Lights**

The Borough is working with Mr. Jim Halsey of the JCP&L wiring department. The Borough is waiting on JCP&L to install wiring prior to the repair of the damaged section of boardwalk. JCP&L indicated that some of the existing wiring is in need of replacement and that some openings need to be made in the existing boardwalk. The Borough is waiting for JCP&L to show them where to make the openings.

# **Boardwalk and Railings**

As indicated above The Borough is waiting on JCP&L to install wiring prior to the repair of the damaged section of boardwalk. Boardwalk repair and railing installation will be coordinated by Doug Caron and completed by the Borough immediately after JCP&L runs the necessary wiring.

# Beachclub Restaurant

Restaurant site has been cleared. Joseph Tomaino, AIA Consulting Architect is handling the coordination and the design of this project.

Our office has completed a flood elevation certification for submission to FEMA and the Construction Official, indicating that the Beachclub Restaurant is not located in a flood hazard area.

# **Pool Pump Room**

Pump Room roof has been repaired by the Department of Public Works. The electrical transformer was recently replaced and electric service has been turned on.

Joseph Tomaino, AIA Consulting Architect has made a site visit with his electrical engineer. The Borough has provide the electrical engineer with design specification and technical data from the plates on the existing pool pumps for further evaluation of the control panel design requirements.

## **Well Points**

Burke construction has pulled the existing well points and provided a proposal to install a new well point system. Leon S. Avakian, Inc. recommends proceeding with the new well points system based on our meeting and recommendations by Jason Burke.

However, our office will have to further evaluate the impact of the Army Corps beach nourishment on the location and elevation of the well points..

#### **Beach Club Pool Liner**

Borough approved RenoSys to repair the portion of pool liner that was damaged during Superstorm Sandy. Contractor has indicated that they will have the repair of the pool liner completed no later than May 24<sup>th</sup>, prior to Memorial Day weekend. During the repair, the contractor will investigate the cause of water accumulating beneath liner.

#### **Snack Bar and Bandstand**

Joseph Tomaino, AIA Consulting Architect is working with the Borough and will provide preliminary drawings on a community room in this area in lieu of reconstruction of snack bar and bandstand.

The Borough is considering a deck overhead to connect the north and south upper umbrella decks.

There was a short discussion regarding lighting at the cabanas which will be addressed further.

Mr. Avakian spoke about beach replenishment, stating he believes the project will start in the winter.

#### **PUBLIC HEARING**

Robert Scally asked about guest books and single tickets and Comm. McLoughlin stated guest passes can be purchased in groups of 10. They will still be good for the following year.

Mr. Scally stated his sidewalks can be a tripping hazard. A realtor friend told him not to fix it because he would be liable.

Comm. Bolan stated only if it was not fixed correctly.

There being no further comments, public hearing was closed and the Commissioners adjourned to caucus and did not reconvene.
