John McNamara stated they got caught up in Sandy. Their cabinets got backordered and are now coming on the 16<sup>th</sup>. It is only a matter of hanging them up on the walls. The fence is coming on the 15<sup>th</sup>. It, too, was backordered. They have a four year old niece that they watch and the property backs up to a railroad track.

Mayor McLaughlin asked how long they would need and Mr. McNamara stated they would need two days for each project. Hopefully, they can be done at the same time.

Mayor McLaughlin asked what is in the kitchen now and Mr. McNamara stated there are four blank walls.

There were no public comments.

## 101 Spier Avenue

John Morgan stated a water pipe burst and blew out the ceiling in the family room about three weeks ago. They have demolished everything, but it now needs to be repaired. After the plumbing is repaired, they need to put back the ceiling. He feels it could all be done by the end of next week as long as they don't find any other problems.

Comm. McLoughlin asked if the bathroom was out of commission and Mr. Morgan answered that not only is the bathroom out of commission, but they do not have water to half of the house.

There were no public comments.

### 15 Corlies Avenue

Pat McGinnis stated she had some shingles blow off from Sandy. She has rain blowing into her attic and she also needs to repair her gutters. Contractors have been working on the more serious projects first, and they can finally get to her. She has asked for seven days, but it could probably be done in four or five days.

Mayor McLaughlin asked if she was getting damage in the house, and Ms. McGinnis state4d she was. Mayor McLaughlin asked if she would need a dumpster and Mrs. McNamara stated she would not, it is only a repair.

There were no public comments.

There was discussion among the Commissioners, with Comm. McLoughlin commenting that it is telling that no one from the public had any comments.

Mayor McLaughlin asked that any cutting be done in the garage or house. He asked that the homeowners coordinate with Ms. Osborn as to the dates the repairs will take place.

## **OTHER BUSINESS**

Mayor McLaughlin asked why the beach lifeguards leave at 6 PM. They should be working until 6:45 PM as the Club is open until 7 PM. He suggested leaving one beach open until 6:45 PM. Comm. McLoughlin added that it is only 1 hr. of overtime.

Comm. McLoughlin asked about the status of the restaurant plans and Mayor McLaughlin stated that Joe Tomaino should have something by the end of the week.

Comm. McLoughlin suggested meeting at the firehouse to show the plans.

### **PUBLIC HEARING**

Randi Sternberg thanked the Borough for removing the construction trailer. Doug was out and sweeping the debris. She spoke to Lori several times and she has been very good in helping her. She asked that something be done with the weeds and the planters. That end of the beach has been neglected. The DO NOT ENTER sign is not working.

Dr. Sternberg stated a lot of money has been spent on rehabilitating the Beach Club. He has a couple of requests. The north end has been treated like a wicked sister. The ramp needs to be re-paved. You cannot walk down the ramp without hurting your feet. They also need new railings.

Ms. Osborn stated that she has spoken to Mr. Caron and that end will be cleaned up and the pots planted.

Joan March stated that Allenhurst is one of the only towns that NJ American Water has fixed. There are other towns still struggling with dirty water.

Mayor McLaughlin asked the Administrator to get a cost from the Borough Engineer on re-coating the ramp. There was some discussion regarding a blue spongy material that was used in Deal.

Comm. Bolan commented that the ramp is most certainly not up to code as it is so steep. When you start to rehabilitate something, you have to bring it up to code.

Maryann Dowling thanked the Commissioners for putting up stop signs on Page Avenue. However, there is not one on her corner. They should be on every corner.

Mayor McLaughlin stated he would move one to that corner and the Borough will purchase more so that every corner will have one. He has also asked that a Class II Special be assigned to that intersection. He would like a report as to when the Special is there and for how long.

There was some discussion regarding extending the Beach Club season. Mayor McLaughlin stated they had some problems getting the pool up and running, they started the season a little later and also had some electrical problems at the cabanas. He thanked everyone for their patience this season.

After discussion, it was agreed that the Club will remain open until September 22<sup>nd</sup>.

Tim Moriarty thanked the Commissioners and stated there was some back and forth over the Corlies Avenue entrance and when it opens. He would like a ruling from the Commissioners.

Comm. McLoughlin stated that management has already made that rule. The side gate opens at 11 AM. It will remain that way.

Mr. Moriarty stated the website is not being updated, even though they are getting e-mail blasts.

Mr. Caron stated that with the 4<sup>th</sup> of July weekend, the program was almost overloaded. They really need to get their own server at the Club. They are currently pulling from Borough Hall, but it isn't enough. Stephen and Rachel have been working very diligently, but the computer is not cooperating.

Stephen Rogers stated he and Rachel are asked a lot about purchasing single tickets. After a short discussion, the Board asked that an ordinance be drafted to permit the purchase of single tickets. Single tickets must be used immediately.

Chris Rogers stated that the power outage at the cabanas had nothing to do with any individual or band. It was JCP&L.

There being no further comments or any further business, Comm. Bolan moved, seconded by Comm. McLoughlin, that the meeting be adjourned. Motion carried.
