ORDINANCE #2013-08 AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF ALLENHURST, CHAPTER X, BEACH REGULATIONS

VOTE: Comm. Bolan-AYE; Mayor McLaughlin-AYE

PROCLAMATION

Mayor McLaughlin proclaims September as "Childhood Cancer Awareness Month"

WHEREAS, Thirty-six children in the United States will be diagnosed with cancer each day and at an average age of six years old; and,

WHEREAS, One out of Five children diagnosed with cancer will not survive the disease; and, **WHEREAS**, The types of cancers that affect children are most often very different from those that affect adults; and,

WHEREAS, Childhood cancer is not just one disease, but is made up of a dozen types and countless subtypes of cancer; and,

WHEREAS, Childhood cancer spares no socioeconomic, ethnic, racial or geographic class; and.

WHEREAS, Pediatric cancer is the leading cause of death by disease in the US for children under 15 years of age; and,

WHEREAS, The causes of most pediatric cancers are largely unknown and not strongly linked to lifestyle, unlike adult cancers; and,

WHEREAS, Two-thirds of childhood cancer patients will develop long-lasting chronic conditions resulting from treatment; and,

WHEREAS, The childhood cancer rates have been rising for the past few decades, and approximately 11,630 children in the US under the age of 15 will be diagnosed with cancer in 2013; and,

WHEREAS, Cancer kills more kids than AIDS, asthma, cystic fibrosis, diabetes, and muscular dystrophy combined; and,

WHEREAS, In the last 25 years, only two drugs have been specifically developed for children's cancer; and,

WHEREAS, Less than 5% of the Federal government's total funding for cancer research is dedicated to childhood cancers, and only about 3% of funds raised for the National Cancer Institute go directly to pediatric cancer research; and,

WHEREAS, The funding for pediatric cancer research has gone down steadily since 2003; and, WHEREAS, Despite the facts, childhood cancer research is vastly and consistently underfunded; and,

WHEREAS, Despite major advances in treatment, it is still critically important to conduct research and increase awareness regarding pediatric cancer;

NOW, THEREFORE, BE IT RESOLVED, That I, Mayor David J McLaughlin, along with the entire Governing Body, do hereby proclaim September, 2013 as

"CHILDHOOD CANCER AWARENESS MONTH"

in the Borough of Allenhurst in order to help raise awareness of pediatric cancer and its victims.

OTHER BUSINESS

Mayor McLaughlin stated that our head lifeguards, Chris Wilson and John Cullen and one of our senior lifeguards, Kat Dowling participated in a national lifeguard tournament in California. They were part of a Monmouth County team and they finished in third place. Congratulations to them. Also, Allenhurst held its first tournament in town which was very successful.

Comm. Bolan added that he was stopped by a former resident who told him this was the first year he felt totally comfortable with his son swimming in front of the lifeguards. He had some very favorable comments regarding the lifeguards and their professionalism.

PRESENTATIONS

Cpt. Schneider and Ptl. Carafa presented the Borough's new narcotics dog, Bia, to the Borough and Commissioners. Ptl. Carafa spoke about the narcotics program the Borough is starting. Cpt. Schneider stated there is not a drug problem in Allenhurst, but there is a problem with drugs running through Allenhurst. This program will pay for itself through seizures and will be a benefit to the Borough.

Cpt. Schneider also presented certificates to Mr. Cattan and the Sephardic Institute in recognition of contributions to the narcotics program and to Joseph Dweck, who purchased and outfitted two bicycles for the Police Department.

Mayor McLaughlin stated that Rutgers University presented football jerseys to each town. They have been signed by the coach. He presented the jersey to the Allenhurst Fire Department to hang in the firehouse along with other memorabilia from Allenhurst. Mayor McLaughlin also thanked Rutgers for the jersey.

PUBLIC HEARING

Steve Feldman, One Elberon Avenue, stated he was hoping to get in on Phase I for the beach replenishment. He will be hosting a fundraiser this Thursday in case the town wanted to do some additional work. Everyone is welcome.

Mayor McLaughlin asked Doug Caron and Chris Rogers to think about doing an overnight sleepover at the Club in September. Each child will have to be accompanied by an adult.

Mr. Caron and Mr. Rogers stated they would discuss it and come back with recommendations.

Mr. Moriarty asked when the Commissioners thought the restaurant would be done. Will it be done before the next season? Mayor McLaughlin stated that was their goal.

There being no further comments or any further business, Comm. Bolan moved, seconded by Mayor McLaughlin, that the meeting be adjourned. Motion carried.
