PUBLIC HEARING

Mr. Falcone asked if there was any further news on the merger and Comm. McLoughlin stated a sub-committee had been set up and has had one meeting. They will meet again on May 5^{th} . They will report back to the Board of Commissioners who will report to the public.

Frank Remadeli, Loch Arbour, asked if these meetings were open to the public. Comm. McLoughlin stated they were, but there would be no public hearing as it is only a workshop.

Comm. Bolan stated that Paul Fernicola did write to the Commissioner of Education for further clarification. He did not know whether he received an answer.

Greg Havlusch asked if the next step was to adopt an ordinance. He asked when this would happen. Comm. McLoughlin stated the Commissioners have 120 days to act, but if they decide to do an ordinance, it would have to be by July or August in order to get a question on the ballot.

Mr. Havlusch stated that at the meeting on March 8th, Brendan Queenan was hired as Assistant Beach Club Manager at a salary of \$8,200.00. On April 20th he submitted his resignation. Tonight, the Board hired Mr. Foley at \$12,000. He is formerly of Deal Casino. He asked what Allenhurst is getting for the extra money. Particularly when we have yet to see any success with the new management. Especially at the exorbitant salaries.

Comm. Bolan objected to the question as he did not feel there has not been success.

Mr. Falcone asked why a 50% increase, and Comm. McLoughlin stated he felt he will bring a lot to the Club. He has been a manager and has a lot of experience.

Mr. Havlusch asked who is in charge of the ABC and Commissioner McLoughlin answered that, ultimately, the Commissioners are responsible. Mr. Havlusch questioned whether the Beach Manager was a Department Head position and Comm. McLoughlin stated it is unde the prevue of the Public Works Department.

Kim Mehr asked who did the hiring of the Beach Club employees and asked whether Allenhurst residents had any advantage over non-residents.

Comm. McLoughlin stated he would say so, however, it was the Mayor who went over the applications. Comm. Bolan added that former ABC members are viewed more favorably.

Mr. Havlusch asked about the Fire Department raffle and asked if there was a limit on the number of chances being sold.

Comm. McLoughlin stated the Fire Company got a list of Beach Club members and are sending out fliers.

Anthony Mauro asked if the Borough had looked at Optimum for cable services. Ms. Osborn explained that the only cable company in Allenhurst is Comcast. Verizon is not considered a cable company, but a phone company. The cable companies have split the areas into regions and Optimum would not be interested in moving into Allenhurst.

Mr. Remadeli stated he saw that Carmine's was moving to Allenhurst. He asked if they had a liquor license. Comm. McLoughlin replied that they did not, but added they should be open by Memorial Day weekend.

James Caulfield spoke about traffic on Ocean Place, stating it really should be one way. It is very narrow and tricky to navigate. Comm. McLoughlin stated he would speak to the Captain about it.

Mr. Caulfield stated the town does a lot of mailings and asked if they would consider sending a flier with a checkbox on whether people are in favor of the merger with Loch Arbour or not. There are a lot of residents who don't get to vote and this would give them a chance to be heard.

Comm. Bolan stated he did not know enough yet to say whether the governing body is in favor of this proposition or against it yet.

There was a discussion on the proposed merger and the school issues that Allenhurst could face as well as a discussion on choice schools.

Mr. Havlusch stated that in the Beach Club handbook, it is advertised that there will be three meetings at the Beach Club. He asked when they would be. Ms. Osborn stated they will be the second meetings in June, July and August and will be regular Board of Commissioner meetings.

Mr. Remadeli asked what regulations Allenhurst imposes for pools and Ms. Osborn gave the setback and impervious surface requirements and stated there is a Planning Board sub-committee set up to review regulations for pools and they are meeting Thursday morning. Comm. McLoughlin added that they are looking into regulations for the actual construction of the pools. One of the issues they have is a high water table.

There being no further comments or questions, public hearing was closed and as there was no further business, Comm. McLoughlin moved, seconded by Comm. Bolan, that the meeting be adjourned. Motion carried.
