WHEREAS, The Local Finance Board of the State of New Jersey is authorized to prescribe reports pertaining to the local fiscal affairs, as per R.S. 52:27BB-34; and,

WHEREAS, The Local Finance Board has promulgated a regulation requiring that the governing body of each municipality shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, at a minimum, the sections of the annual audit entitled:

WHEREAS, The members of the governing body have personally reviewed at a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled:

General Comments Recommendations

as evidenced by the group affidavit form of the governing body; and,

WHEREAS, Such resolution of certification shall be adopted by the governing body no later than forty-five days after receipt of the annual audit, as per the regulations of the Local Finance Board; and,

WHEREAS, All members of the governing body have received and have familiarized themselves with at least the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and,

WHEREAS, Failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

"R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined no more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

OTHER BUSINESS

Water Tower

Peter Avakian, Borough Engineer, spoke about the water tower, stating he received a report from AT&T. They were concerned with the structural integrity of the water tower. They are suggesting the borough demolish the tower and they will put up a monopole. He stated he is leary of monopoles. He stated when the suggestion of a monopole is vendor driven, it is not usually well received.

Mayor McLaughlin asked what the cost would be to stabilize the tower. Mr. Avakian stated that the diagonals would have to be replaced. He didn't think the cost would be extremely high. Most of the other problems were rust and deterioration, but not necessarily structural.

Ms. Osborn stated that demolition would cost between \$50,000 and \$75,000. The annual revenue from the three vendors is \$102,000.

There was a short discussion on the cost to paint the water tower in which Mr. Avakian stated the last quote they received was \$63,000, but that was for both inside and outside. This is a little different as it is not a working water tower. They only want to paint it for cosmetic purposes. Brielle renovated their water tower at a cost of \$550,000.

Mayor McLaughlin asked if Peter had a ballpark idea of the cost to stabilize the tower and Mr. Avakian stated he would get a quote on exterior painting and repair of the diagonals.

Comm. McLoughlin stated that in the 90's, there was discussion about taking the water tower down.

Bob Scally stated that the tower used to have Borough of Allenhurst written on it.

Noise Meter

Chief Richter presented the new noise meter to the Commissioners and showed them how it would work.

Mayor McLaughlin explained that the Borough had adopted a noise ordinance which uses decibels. He explained how noise complaints would be handled.

Patches

Chief Richter presented the new police patches to the Commissioners.

Assessment Pilot Program

Mayor McLaughlin stated that the assessments in town have gone down. He asked how the reassessment took place as nobody came in to inspect his house.

Peter Barnett, Borough Assessor, stated that a reassessment looks at sales, judgments, building permits, etc., whereby a revaluation, which will be done next year, includes a physical inspection of the property.

Mr. Barnett explained the Pilot Program which is being done in Monmouth County. There has been a significant change. It will be his responsibility every year to do a reassessment. Homes will be inspected every year. There will be a 100% reassessment of the town and after that a 20% revaluation every year.

Mr. Barnett added that the County may take over the job of Assessor and Tax Collector.

Mayor McLaughlin stated that people think because assessments went down, their taxes will go down.

Mr. Barnett stated that was not the case. He added that the tax rate will be struck early and appeals will have to be filed earlier.

PUBLIC HEARING

Bob Scally stated he knows an e-mail went out regarding burglaries. Not everyone has e-mail. He talked to his neighbor, who didn't know anything about the burglaries. He asked if the Borough could send letters.

Mayor McLaughlin stated that this is a quicker response. The cost to send letters is very expensive as they would have to be sent first class. He stated they could use the reverse 911 system more often.

Tim Moriarty stated the Chief talked about the noise ordinance. He asked if there were different noise levels for day and night. Mayor McLaughlin stated that was correct. He asked how repeat abusers would be handled and Comm. McLoughlin stated they have to follow the state statute.

Mayor McLaughlin wished everyone a Happy Thanksgiving and the meeting adjourned to caucus.

After reconvening, Comm. McLoughlin moved, seconded by Mayor McLaughlin that the meeting be adjourned at 8:47 PM. Motion carried.
