OTHER BUSINESS

There was a discussion on the parking lot at 417 Euclid Avenue, in which Comm. Bolan stated they are in friendly negotiations with the property owner on the condition of his lot. The borough has an easement for the trucks to come into the Public Works yard. It was decided that the Borough would pay for a portion of repaying and re-grading the lot, provided they see an estimate in advance.

The Commissioners next discussed electric for the tiki bar. They had received a quote from Bryan McCarthy in the amount of \$6,000 and a quote from Check Electric in the amount of \$4,800 to provide electric service to the bar. Comm. Bolan stated it was too high for a bar that will only be open on weekends during the summer. It was decided that the Borough would provide a generator for electrical service.

There was a discussion on the tall grass at 105 Cedar Avenue. The Mayor authorized the Clerk to have the grass cut and a lien placed against the property.

There was a discussion on park improvements in which the Board decided they would add one tennis court. There are a number of trees that need to come down and they will get an estimate and take of that in the Fall.

There was a short discussion regarding an e-mail received with a video of the garbage truck on the Asbury circle. It was determined that the Borough employee did not violate any traffic laws. Comm. Bolan stated he would respond to the e-mail.

PUBLIC HEARING

Tim Moriarty asked about having an arrow placed on the left side of Corlies Avenue, coming away from the beach. Mayor McLaughlin stated he remembers the discussion last year and he would speak with Doug when they are less busy.

The Mayor authorized an e-mail blast that the Club will be open on Saturday.

There was a short discussion on sand replenishment and extension of the wellpoints and outflow pipes.

There being no further comments or any other business, Mayor McLaughlin moved, seconded by Comm. Bolan that the meeting be adjourned at 8:15 PM. Motion carried.
