PUBLIC HEARING

Maryann Dowling stated that some groups of people leave a mess when they leave the Beach Club. She asked if there was any way someone could walk around on Sunday and ask the larger groups to clean up after themselves. Mayor McLaughlin stated he would speak to Wynn Phillips.

Mr. Scally stated that Senator Beck has introduced a bill in the senate concerning rescuing laboratory dogs. If it passes, New Jersey would be one of the first states to do so. He then stated his neighbor's garbage has been a mess. He stated that Doug and Bob have been good and have spoken to his neighbor, but there was garbage out there today. Mayor McLaughlin stated he would speak to the Code Official again.

Tim Moriarty asked if the Borough has any word from Verizon and Mayor McLaughlin answered, no. Mr. Moriarty asked if there was any idea what they want to build and Mayor McLaughlin answered, not yet. Mr. Moriarty asked whether the concrete lockers were going to be replaced and Mayor McLaughlin stated they are looking to do a five-year improvement program at the Club, which may include replacing those lockers.

At this point, Comm. McLoughlin arrived.

The Board discussed a request for filing on Cedar Avenue and the Board determined that since the property owner list was not picked up and people notified, that the request would be denied.

The meeting then adjourned to caucus. After reconvening, Comm. Bolan moved, seconded by Comm. McLoughlin, that the meeting adjourn at 9:20 PM. Motion carried.
