PUBLIC HEARING

Mayor McLaughlin gave kudos to the Fire and First Aid Department for their assistance at the Ocean Grove Fire.

Tim Moriarty stated it was great that the Commissioners were thinking about providing wifi at the Beach Club. He asked if they had given any thought to places where people can plug in.

Mayor McLaughlin stated that they had not thought about it.

Mr. Moriarty stated that at earlier meetings the Board spoke about a new facility charge. Mayor McLaughlin stated it was part of the new ordinance they introduced this evening.

Mayor McLaughlin asked Mr. Caron, Public Works Superintendent, if they could plant shrubbery around the garbage area at the Beach Club. Doug stated they would be able to do that.

There was some discussion of a date for a budget workshop and the following resolution was considered:

There was a discussion on abandoned properties in which Mayor McLaughlin asked if there was any harm in sending a letter to the bank, stating the Borough will take action under the Abandoned Property Act.

Dave Laughlin, Borough Attorney, stated the problem is you can't write a summons against the bank as they have not foreclosed on the property. They probably will not foreclose while the property is in bankruptcy. He stated the Code Enforcement Department can write summonses to the homeowner, and Mayor McLaughlin stated he is doing that, but the owner does not show up for court.

Comm. Bolan suggested calling to see whether they are still in bankruptcy.

Wynn Phillips, Beach Club Manager, spoke about some budget issues.

Comm. McLoughlin asked him whether they had enough radios and Mr. Phillips stated they will need two more as they will have to hire two additional security personnel. They also need to replace three or four units.

There was discussion about putting money in the budget to sell apparel.

Mr. Phillips stated that if they get beach replenishment, he will need two more beach vehicles. If two is not possible, at least one would be appreciated.

Chris Rogers, Facilities Manager, explained that they use the same vehicle to pick up trash and to take the handicapped down by the jetty. They really should have two different vehicles.

There was some discussion as to whether a beach vehicle can be bonded.

Mr. Phillips stated he would like another lifeguard boat.

There was some discussion on opening and closing dates and the Board decided the Club will open on Memorial Day weekend and be open weekends only until June 18, at which point it will be open daily. The Club will close on September 13, 2015.

Mayor McLaughlin noticed that Rose O'Conner has entered the meeting. He stated he received her text regarding the Antique Car Show and the Flea Market. He asked Ms. O'Conner if she had been charging for tables at the flea market to which Ms. O'Conner answered yes. Mayor McLaughlin stated that it was an issue for the town. They cannot use public property for a business to make a profit.

Ms. O'Conner stated the charge was to help defray advertising costs. She stated the Mayor spoke to her about a Chamber of Commerce. She wears many hats and was very busy then, but is less busy now and would consider it. She thinks she has enough experience and information that if she had the cooperation of the town and other business, it would be a major advantage.

Comm. Bolan stated a Chamber of Commerce is a private enterprise and has nothing to do with the Borough.

Mayor McLaughlin stated that he is in the process of setting up a meeting with the town's business to talk about forming a Chamber of Commerce. He has an expert coming to speak to everyone.

Ms. O'Conner stated she appreciated the Borough's support over the years. She presented the Commissioners with an invitation to the wine and cheese event on Thursday.

Comm. Bolan stated that the Borough can give permits for using Borough space and he asked the Borough Attorney to work on such an ordinance.

There being no further comments the meeting adjourned to caucus. After reconvening, Comm. McLoughlin moved, seconded by Mayor McLaughlin, that the meeting be adjourned at 9:40 PM. Motion carried.
