- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality

1. The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

2. That other applicable statutory requirements have been fulfilled.

AN ORDINANCE TO FURTHER AMEND "AN ORDINANCE ESTABLISHING A BEACH CLUB, REGULATING THE USE OF THE BATHING AND RECREATIONAL FACILITIES AT THE BEACHFRONT AND PROVIDING REVENUE IN THE BOROUGH OF ALLENHURST" ADOPTED BY THE BOARD OF COMMISSIONERS ON THE 16TH DAY OF APRIL, 1973.

There was no response to Mayor McLaughlin's request for public comments.

PUBLIC HEARING

Adele Gannon, 318 Allen Avenue stated she was here at a previous meeting and it was mentioned that there was a stream running under her property. She wondered if the borough has any maps. Doug Caron, Public Works Supervisor, stated there were no maps, just a knowledge of a high water table.

Russ McIver, Hume Street, asked what the plans were for police, fire and EMS to deal with Bamboozle. He asked who is paying for overtime. He asked what the borough's position would be regarding parking or sleeping in cars or vagrancy. What is the Borough's plan if there is a civil disturbance?

Mayor McLaughlin stated all officers will be working. The fire and first aid will be doing stand-by at the firehouse. We, unfortunately, have to pay for overtime. The Chief is putting together a plan. There are ordinances in place and they will be enforced. They are being proactive. There will be manned parking at the beachfront.

Chief Richter stated if there is a civil disturbance, it will be handled by Asbury Park and Monmouth County. Their job will be getting people out of town. New Jersey Transit will assist by funneling people to the train station. Asbury Park is anticipating taking 95% of the train traffic. Nobody will be sleeping in cars. They will have the bike patrols out and summonses will be issued. Warnings will not be given. He is getting the promoter's name and will try to bill for overtime, but doesn't know if it will work. They have an obligation to keep order in this town and that is what they will do.

Comm. Bolan asked what happens when someone parks in the 200 block, goes to the concert, gets loaded, goes back to their car, decides they are too drunk to drive and sleeps in their car? Chief Richter stated they will get a summons. If intoxicated, they will call someone to come get the keys and given them a ride or they will be remanded to the county jail.

Chief Richter added that they did secure the Bamboozle area very well. Mr. Caron stated that he will be putting up barriers as well. He will have someone posted to watch the beach also.

Comm. Bolan asked if there is an ordinance restricting being on the beach after a certain time at night? Chief Richter stated the concert will end at 11 PM. People cannot sleep on the beach.

Mayor McLaughlin asked what happens if a driveway is block and Chief Richter stated the owner will be ticketed and towed. Non-stop towing will be on call. The Chief added that he has made up a number of signs saying Bamboozle this way and Garden State Parkway this way to try to keep the traffic flowing.

Mr. Moriarty questioned the web site and meeting dates.

Paul Fernicola, Loch Arbour Mayor, stated they received a response to the 25 questions the joint subcommittee sent to the State. The answers were not satisfactory and he thought the next step would be a joint meeting with loch Arbour and Allenhurst. While the State gave personal

assurances, they don't have a binding effect. He would like to discuss the possibility of proceeding under the Local Option of the Municipal Consolidation Law. Under that statute, it allows them to set a date for election. They can come up with a plan to submit to the Department of Community Affairs. In that way, residents of both towns would have assurances before the consolidation.

Mayor McLaughlin stated they have not had a meeting since they got the answers back from the state. Before that meeting, he felt it would be worthwhile for both towns to meet together first. There is a lot to this Act and there is a big difference.

Mayor Fernicola stated he was thinking an election date may be set for May of 2013.

After some further discussion, it was decided the towns would meet jointly at the Allenhurst regular Board of Commissioner's meeting scheduled for June 12, 2012.

Rose O'Connor spoke about the Allenhurst Outdoor Antiques Market on May 27th. It is a positive thing for the town. She left some cards on the table in front of the dais for the public.

There was a 15 minute recess for refreshments.

After reconvening, Mayor McLaughlin stated he received a call from Mayor Nohilly in Interlaken, stating if Allenhurst were to drop the garbage contract by \$5,000.00. they would adopt it. There was discussion on whether Interlaken is formally requesting a reduction in the contract. Comm. Bolan stated he will be at Interlaken's meeting tomorrow night.

Dave Laughlin, Borough Attorney, discussed a letter received by Jennifer Krimko, attorney for the Cohens regarding 308 Allen Avenue. He explained that a Zoning Determination was issued in 2007 permitting a pool at that location. They found the property was contaminated and they had to remediate the problem. Now they want to put in the pool, but object to following a subsequent ordinance which was adopted in 2011 concerning pool construction. Ms. Krimko claims they can put the pool in under the Permit Extension Act.

Mr. Laughlin stated he agreed with Ms. Krimko's opinion and felt that the Borough may lose the case if it were to go to court.

Comm. McLoughlin stated even though the neighbor may get flooded out? Mr. Laughlin responded that was correct. If the neighbor gets flooded, they will have to sue the other property owner. If this ordinance was made a part of the construction code, they may have had a case.

Mayor McLaughlin stated they have not yet applied for a pool permit and Mr. Laughlin stated the Zoning Determination is a permit. He stated he spoke to Don Beekman, Planning Board Attorney. Originally, he was of a different opinion, but has since changed his mind.

The Board of Commissioners authorized Mr. Laughlin to send a letter to Ms. Krimko allowing the pool, but urging them to abide by the ordinance as they know there is a high water table and flooding is a possibility.

There being no further business, Comm. McLoughlin moved, seconded by Comm. Bolan, that the meeting be adjourned. Motion carried.
