PUBLIC HEARING

Mr. Moriarty stated the Beach Club employees received an e-mail regarding their pictures. He asked if the Board was going to stand by that. Comm. McLoughlin stated that everyone will have to funnel through the main gate. Mayor McLaughlin suggested having someone there to take pictures at 9 AM.

Richard Cumiskey asked if the cabanas would be ready and Ms. Osborn stated that there is still some work to be done on them, including installation of the doors, and plumbing and electric hookups.

Chris Rogers asked about the condition of the street on Spier Avenue after the water company finished their work. Ms. Campagna, Assistant Administrator, stated she spoke to the Engineer today. They will be asking the water company to re-pave the areas that were dug up. Mr. Rogers asked about seeding the grass areas that were disturbed and Ms. Campagna stated she would ask.

There being no further comments, public hearing was closed.

ITEMS FOR DISCUSSION

The Commissioners discussed the following items:

ABC Co-Principal Requests. The following requests were granted for cabana co-principals: Eleanor Williams, Sandra Taylor, Tom Reddy, Dorothy Lehmann, Rose Coyne, Joan McCann, Virginia Marmora, Glenn Heckman, Eleanor Williams, Maureen Bowe, and Cathy Sutley.

Mayor McLaughlin asked Mr. Caron about landscapers dumping grass in the street. Mr. Caron stated that this year is the worst he has seen. Also, small brush, which should be containerized. Mayor McLaughlin suggested giving everyone a letter regarding grass clippings,. Mr. Caron stated he has a letter from Lori from last year, which he has given out. He stated it is the new gardeners in town who are the problem.

Comm. Bolan stated it is not the experienced gardeners, but the day laborers who are the problem. The police should be talking to these people. He suggested an e-mail go out to the Chief.

Mayor McLaughlin asked about sweeping the streets and Mr. Caron, Public Works Superintendent, stated that as soon as Interlaken is done with their sweeper, he will be able to use it. He stated that Ocean Township may have an old sweeper they are putting up for auction. He spoke to Ms. Osborn and she will call Ocean Township to get more information.

Mayor McLaughlin stated there is dirt at the curbline on Cedar Avenue and grass is growing in it. Mr. Caron stated that gardeners are blowing it into the street. Also, if the curbline was swept more often, it would take care of the problem. The responsibility lies with both.

There was a short discussion on the conditions at the JCP&L properties with weeds coming up through the sidewalks and a cracked window in the lobby. Mr. Caron stated that they used to have someone who took very good care of the property. Now they have someone else, and they are not doing a good job. Mayor McLaughlin stated he would speak to Jim Markey about the conditions.

Ms. Osborn presented a request from Legislative District #11 to set up table at ABC for public outreach. After short consideration, the Commissioners denied the request.

Mayor McLaughlin stated he spoke to the Planners, Heyer and Gruel about the JCP&L property. He would like to hire them to talk about it. Comm. Bolan agreed that it would be a good idea.

Donna Campagna, Assistant Administrator, spoke about issues regarding the Beach Club restaurant. She spoke about training on the programming system for the lights. The company wants \$1,000 to come back for a four hour training session. Comm. Bolan stated it was ridiculous. There has been no training for the system. He suggested sending an e-mail to the Architect and to everyone else. Someone should pay to have this training done and it should not be the Borough.

Mrs. Campagna talked about the outside bathroom leak. She is getting estimates for a trench drain and to get the floors epoxied. She will give those estimates to Mr. Laughlin and they will negotiate with Santorini.

Mrs. Campagna stated that Ms. Marzulli still wants credit for her high electric bill.

There was a short discussion on the fence at Allen Avenue and Mrs. Campagna stated that she will have the Borough Engineer include a new design in the plans for the Allen Avenue park project.

Chris Rogers asked if there was anything in the contract about the restaurant lessees having to notify the Borough before doing any kind of work at the restaurant. Mayor McLaughlin answered, absolutely.

Mr. Rogers asked if the Borough is notified and receives money for parties of over 100 people. Mr. Laughlin stated they wrote that out of the contract as it just could not be enforced. They raised the minimum bid amount to cover situations like that.

Mrs. Campagna stated the lessees want a hot water line to the outside drain to wash their mats. Mayor McLaughlin asked if this was something we paid for and did not get. He asked Ms. Campagna to check with the architect. Otherwise, the answer is no.

Mrs. Campagna stated that now there is no air coming through and the kitchen is too hot. Mr. Laughlin stated the wind tunnel effect will always exist if she leaves the door open. Mrs. Campagna stated she has a call in to Breeze Electric.

Mrs. Campagna stated there was a complaint about the sensor in the kitchen. Mayor McLaughlin stated she was told to move her equipment. Mrs. Campagna stated that she has built in refrigerators along the wall that cannot be moved. She is getting an estimate. Comm. Bolan stated it is a completely over-engineered system. It is an embarrassment.

There being no further comments or any further business, the meeting adjourned to caucus. After reconvening, Comm. McLoughlin moved seconded by Comm. Bolan, that the meeting be adjourned at 9:07 PM. Motion carried.
