ORDINANCE #2011-08

AN ORDINANCE OF THE BOROUGH OF ALLENHURST COUNTY OF MONMOUTH AND STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CERTAIN TRAFFIC CONTROL ORDINANCES PREVIOUSLY ADOPTED WITHIN THE BOROUGH

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF ALLENHURST, AS FOLLOWS:

SECTION 1.

That Section 1C of an Ordinance entitled, "AN ORDINANCE REGULATING PARKING IN THE BOROUGH OF ALLENHURST, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY", adopted May 15, 1968, be amended to read:

Section 1C. For more than two (2) hours between the hours of 8 AM and 6 PM on the following streets, avenues or portions thereof:

Name of Street	<u>Side</u>	<u>Location</u>
Allen Avenue	Both	Page Avenue to Lake Drive
Cedar Avenue	Both	Page Avenue to Lake Drive
Corlies Avenue	Both	Page Avenue to the railroad right-of-way
Corlies Avenue	Both	Railroad right-of-way to Lake Drive
Elberon Avenue	North	Page Avenue to Main Street
Main Street	Both	Entire length with the exception of the 200 block in Front of Centennial Park and Selby Park
Spier Avenue	Both	Page Avenue to the railroad right-of-way
Spier Avenue	South	Lake Drive to railroad right-of-way

SECTION 2.

That Section 1D of an Ordinance entitled, "AN ORDINANCE REGULATING PARKING IN THE BOROUGH OF ALLENHURST, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY", adopted May 15, 1968, be added to read as follows:

Section 1D - Permit Parking.

No person shall park a vehicle on streets or parts of streets as described within the
following sections unless an appropriate and current parking permit issued by the Borough
of Allenhurst is displayed on said vehicle for those streets or parts of streets as described or
listed within the following sections:

Elberon Avenue	Both	Between Page Avenue and Main Street
Allen Avenue	Both	Between Page Avenue and Main Street
Corlies Avenue	Both	Between Page Avenue and Main Street
Spier Avenue	Both	Between Page Avenue and Lake Drive
Cedar Avenue	Both	Between Page Avenue and Lake Drive

SECTION 3.

All other ordinances and parts of ordinance in conflict or inconsistent with this Ordinance, are hereby repealed, but only to the extent of such inconsistency.

SECTION 4.

Should any section, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portion of this Ordinance shall not be affected thereby and shall remain in full force and effect, and to this end, the provisions of this ordinance are hereby declared to be severable.

SECTION 5.

This Ordinance shall become effective after final adoption and publication as provided by law.
