

ORDINANCE #2013-07

**AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF ALLENHURST,
CHAPTER X, BEACH REGULATIONS**

BE IT ORDAINED, By the Board of Commissioners of the Borough of Allenhurst that Section 10-1.6 of Chapter X, BEACH REGULATIONS of the Codified Ordinances of the Borough of Allenhurst be amended as follows: (the following language shall replace that presently existing in the Codified Ordinances):

SECTION 10-1.6 Service and Use Charges

d. *Guest Charges.* Each adult (age 12 and older), individual bathing guest using a member's bathhouse or cabana –one (1) guest pass per day, with the exception of Holiday weekends, which include the weekend of Father's Day, July 4th weekend and Labor Day weekend, where two guest tickets shall be charged until 3 PM. Members may use one Guest Pass per guest after 3 PM on holiday weekends. Children under age 12 will be charged one guest pass. Children, age 3 and under will be admitted, no charge. Packages of guest tickets will be sold in groups of ten (10) passes for \$100.00. These passes will be valid for guests when accompanied by a registrant of the Allenhurst Beach Facilities.

BE IT FURTHER ORDAINED, By the Board of Commissioners of the Borough of Allenhurst, that Section 10-1.7 of Chapter X, BEACH REGULATIONS of the Codified Ordinances of the Borough of Allenhurst be amended as follows: (the following language shall replace that presently existing in the Codified Ordinances):

SECTION 10-1.7 Occupancy Restriction.

It is to be noted that the bathhouses and cabanas described above are restricted in their use as follows:

- a. *Minimum Occupancy:* Two (2) persons, at least one (1) of whom shall be an adult.
- b. *Maximum Occupancy for Bathhouses:* Two families, but not to exceed a total of ten (10) persons for those who were members as of 2012, and eight (8) persons for new members beginning with the 2013 season.
- c. *Maximum Occupancy for Cabanas:* Two families, but not to exceed a total of ten (10) persons.

Except as herein provided, the Codified Ordinances of the Borough of Allenhurst shall remain in full force and effect.

The provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of this ordinance shall stand notwithstanding the invalidity of any part.

This Ordinance shall take effect after publication and adoption according to law.
