ORDINANCE #2015-03

AN ORDINANCE TO AMEND CHAPTER X, BEACH REGULATIONS, OF THE CODIFIED ORDINANCES OF THE BOROUGH OF ALLENHURST

BE IT ORDAINED, By the Board of Commissioners of the Borough of Allenhurst that Section 10-1.6 of Chapter X, BEACH REGULATIONS of the Codified Ordinances of the Borough of Allenhurst be amended as follows: (the following language shall replace that presently existing in the Codified Ordinances):

SECTION 10-1.6 Service and Use Charges

1. Each facility is limited to two families. Each family consists of no more than three generations, (grandparents, parents, children). Additional members may be added for a facility surcharge of \$250.00. This surcharge is in addition to the following membership fees:

- d. *Guest Charges*. Each adult (age 12 and older), individual bathing guest using a member's bathhouse or cabana –one (1) guest pass per day, with the exception of Holiday weekends, which include the weekend of Father's Day, July 4th weekend and Labor Day weekend, where two guest tickets shall be charged until 3 PM. Members may use one Guest Pass per guest after 3 PM on holiday weekends. Children under age 12 will be charged one guest pass. Children, age 3 and under will be admitted, no charge. Packages of guest tickets will be sold in groups of ten (10) passes for \$150.00. These passes will be valid for guests when accompanied by a registrant of the Allenhurst Beach Facilities. Single passes may be purchased for \$20.00 each. These passes will be valid for guests when accompanied by a registrant of the Allenhurst Beach Facilities.
- e. Combination Charges: Where there is a joint tenancy by an Allenhurst resident registrant and a non-resident in any of the accommodations referred to in Sections I and II hereof, the rates for said accommodations will be as follows:

h. A recreation program shall be established which shall be open to all children who are members of the Allenhurst Beach Club between the ages of five (5) years and twelve (12) years at the discretion of the Recreation Director. The program shall run for seven (7) weeks, during the Beach Club season from 10:00 AM to 3:00 PM, Monday through Friday and will not run on those days the Beach Club is closed for inclement weather or any other unforeseen circumstance.

The cost for participation in this program will be four hundred fifty (\$450.00) dollars for the first child and four hundred (\$400.00) dollars per child for additional children from the same family.

SECTION 10-1.9 Daily Beach Admission.

There is hereby established a rate for daily admission to the bathing beach at the Allenhurst Beach Facilities as follows:

The fee for daily admission, which does not permit use of the pools, the snack bar, the recreational facilities and other facilities at the Allenhurst Beach Club shall be ten (\$10.00) dollars per person for weekdays, weekends and holidays. Children under the age of twelve (12) shall be admitted free of charge.

SECTION V Except as herein provided, the remainder of Chapter X, BEACH REGULATIONS, shall remain in full force and effect.

<u>SECTION VI</u> The provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of this ordinance shall stand notwithstanding the invalidity of any part.
