

ORDINANCE 2015-17

AN ORDINANCE REVISING THE PARKING ORDINANCES OF THE BOROUGH OF ALLENHURST.

WHEREAS, the Borough Council of the Borough of Allenhurst has determined that it is in the best interests of the community to revise certain portions of its existing Parking Ordinances to address the needs of the community;

NOW THEREFORE, BE IT ORDAINED by the Borough of Allenhurst, County of Monmouth, State of New Jersey, that the Borough of Allenhurst Revised General Ordinances are hereby amended and supplemented as follows:

CHAPTER VII TRAFFIC

7-4 PENALTIES; be and is hereby amended to increase the penalty to one hundred (\$100.00) dollars. The new Ordinance shall state the following:

Unless another penalty is expressly provided by New Jersey Statute or in this chapter, every person convicted of a violation of a provision of this chapter or any supplement thereto shall be liable to a penalty of not more than one hundred (\$100.00) dollars or imprisonment for a term not exceeding fifteen (15) days or both.

7-12.2 TIME LIMIT PARKING IN BUSINESS DISTRICT; be and is hereby amended to provide additional spaces and the new Ordinance shall state the following:

a. Fifteen (15) minute parking spaces shall be provided for in the business district as follows:

1. Four (4) spaces on the west side of Main Street between Elberon and Allen Avenues.
2. Two (2) spaces on the north side of Spier Avenue, east of the railroad tracks
3. Two (2) spaces on the west side of Main Street between Allen and Corlies Avenues.
4. Two (2) spaces on the east side of Main Street between Cedar Avenue and the Allenhurst Border with Deal.
5. Two (2) spaces on the east side of Main Street between Allen Avenue and Corlies Avenue.

7-15 PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS; be and is hereby amended and the new Ordinance shall state the following:

- a. No person shall park or stand a vehicle between the hours specified any day (except Sundays and public holidays) upon any of the streets described.

7-39.1 Handicapped Parking on Streets; be and is hereby amended to relocate certain spaces and provide additional spaces and the new Ordinance shall state the following:

In accordance with the provisions of N.J.S.A. 39:4-197, the following on-street locations are designated as handicapped parking places. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission, or a temporary placard issued by the Chief of Police. No other person shall be permitted to park in these places.

Allen Avenue	Southerly	2	Between the intersection of Ocean Place and the eastern terminus of Allen Avenue.
Allen Avenue	Northerly	1	Between Main Street and the N.J. Transit Rail Road Tracks
Corlies Avenue	Southerly		Adjacent to the southerly line of Corlies Avenue at the vehicle gate of the pool complex, beginning at a point 46 feet west of the easterly terminus of Corlies Avenue and extending in a northwesterly direction for a distance of 25 feet
Main Street	Westerly	1	Between Spier Avenue and Cedar Avenue.
Main Street	Easterly	1	Between Corlies Avenue and Allen Avenue.

Main Street	Westerly	1	Between Allen Avenue and Elberon Avenue.
Main Street	West	1	Beginning at a point 30 feet south of the southerly curb line of Corlies Avenue and extending to a point 20 feet south thereof
Ocean Place	Easterly	1	Adjacent to the easterly line of Ocean Place beginning at intersection of northerly line of Cedar Avenue with Ocean Place and extending in a northerly direction along the easterly line of Ocean Place for a distance of 20 feet
Ocean Place	Easterly	4	Adjacent to the easterly line of Ocean Place, starting at a point along the southerly line of Corlies Avenue and extending south for 4 parking spaces.
Ocean Place	Easterly	1	Adjacent to the easterly line of Ocean Place, beginning at a point 138 feet south of the dead end of Ocean Place, its northerly terminus, and extending in a southerly direction 20 feet to a point 32 feet north of the southeast corner of Cedar Avenue and Ocean Place
