

## **ORDINANCE #2016-09**

### **AN ORDINANCE TO AMEND CHAPTER VII, PARKING REGULATIONS, OF THE CODIFIED ORDINANCES OF THE BOROUGH OF ALLENHURST**

**WHEREAS**, The Board of Commissioners of the Borough of Allenhurst has determined that it is in the best interest of the community to revise certain portions of its existing Parking Ordinances to address the needs of the community;

**NOW, THEREFORE, BE IT ORDAINED**, By the Borough of Allenhurst, County of Monmouth, State of New Jersey, that the Borough of Allenhurst Revised General Ordinances are hereby amended and supplemented as follows:

Chapter VII, Section 14 (7-14) be and is hereby revised to delete the “No Parking” restriction described as on Allen Avenue, on its northerly side, at the location described as “Between the concrete boardwalk and Ocean Place, an area beginning at the foot of the concrete stairs leading to the Allenhurst Beach Club kitchen facilities, a distance of twenty (20) feet”.

Chapter VII, Section 17 (7-17) be and is hereby revised to add the following subsection “c” which shall read as follows:

- c.   Parking reserved for Allenhurst Beach Club Tenant(s)
  - 1.   On Allen Avenue, on its Northerly side, in an area and location described as “Between the boardwalk and Ocean Place, an area beginning at the foot of the concrete stairs leading to the Allenhurst Beach Club kitchen facilities, a distance westerly of forth (40) feet,” which has been previously marked as a “No Parking Zone” in front of the trash receptacle used by the tenants of the Allenhurst Beach Club.
  - 2.   Said area shall be marked as “Reserved” as parking for the Tenant(s) of the Allenhurst Beach Club restaurant.
  - 3.   Any person, other than the tenant(s) of the Allenhurst Beach Club restaurant parking a motor vehicle in the above referenced “reserved” parking area shall be liable for a fine of one hundred (\$100.00) dollars for the first offense and for subsequent offenses, a fine of at least one hundred (\$100.00) dollars and up to ninety (90) days community service on such terms and in such form as the Court shall deem appropriate or any combination thereof.
  - 4.   Any vehicle parking in violation of this section shall be subject by removal by a law enforcement officer. It shall be the obligation of the owner of the motor vehicle to pay the reasonable costs for the removal and for any storage which may result from the removal.

And, it is further

**ORDAINED** that except as herein above provided, the remainder of Chapter VII, TRAFFIC, shall remain unaltered and in full force and effect; and it is further

**ORDAINED** that the provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of this ordinance shall stand notwithstanding the invalidity of any part; and it is further

**ORDAINED**, That this Ordinance shall take effect after publication and adoption according to law.
