ORDINANCE 2017-11

AN ORDINANCE REVISING THE PARKING ORDINANCES OF THE BOROUGH OF ALLENHURST.

WHEREAS, the Borough Council of the Borough of Allenhurst has determined that it is in the best interests of the community to revise certain portions of its existing Parking Ordinances to address the needs of the community;

NOW THEREFORE, BE IT ORDAINED by the Borough of Allenhurst, County of Monmouth, State of New Jersey, that the Borough of Allenhurst Revised General Ordinances are hereby amended and supplemented as follows:

I. Chapter VII, section 17 (7-17) be and is hereby revised to adjust the description in subsection c. 1. to reflect changes following the creation of the Allen Avenue Park. Section c. 1. is hereby deleted and replaced with the following:

c. Parking reserved for Allenhurst Beach Club (“ABC”) Tenant(s)

1. On Allen Avenue, along its northerly side line, in an area and location described as “Beginning in front of the fire access standpipe at the extreme southwest corner of the ABC Restaurant building and proceeding westerly to the end of the dumpster enclosure area immediately adjacent to the side of the ABC lockers” which has been marked as a “No Parking Zone” in front of the trash receptacles used by the tenants of the ABC.

And, it is further Ordained that

II. Chapter VII, section 12 entitled “PARKING TIME LIMITED ON CERTAIN STREETS,” subsection 12.1 entitled “Non-Metered Time-Limited Parking” as respects time limited parking on Allen Avenue be and is hereby revised to read as follows:

Allen Ave.	Both	2 hours	Mon. to Fri.	8:00 a.m. to 6:00 p.m.	Entire length
Allen Ave.	Both	2 hours	Mon. to Sat.	8:00 a.m. to 6:00 p.m.	Page Ave. to Lake Drive
Allen Ave.	Both	2 hours	Mon. thru Sun.	8:00 a.m. to 6:00 p.m.	All points east of the westerly side line of Ocean Place (extended) to the eastern end of Allen Ave.

And, it is further Ordained that

III. Chapter VII, section 39 entitled “HANDICAPPED PARKING,” subsection 39.1 entitled “Handicapped Parking on Streets” be and is hereby revised to reflect additional locations for Handicapped Parking following the Allen Avenue Park project by adding the following locations to the list of locations:

<i>Street</i>	<i>Side(s)</i>	<i>No. of Spaces</i>	<i>Location</i>
Allen Ave.	North	1	Between the intersection of the easterly side line of Ocean Place with Allen Ave. and the eastern terminus of Allen Ave.
Corlies Ave.	South	3	Along the southerly side line of Corlies Ave., immediately adjacent to the sidewalk running along the north side of the ABC pool complex, at an area suitable for access to the vehicle gate to the ABC pool complex

And it is further,

ORDAINED that except as herein above provided, the remainder of Chapter VII, TRAFFIC, shall remain unaltered and in full force and effect; and it is further

ORDAINED that the provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or phrase hereof shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, clauses and phrases of this ordinance which shall stand notwithstanding the invalidity of any part; and it is further

ORDAINED, That this Ordinance shall take effect after publication and adoption according to law.
