#### **ORDINANCE #2006-11**

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED, "AN ORDINANCE REGULATING PARKING AND DESIGNATING ONE WAY STREETS IN THE BOROUGH OF ALLENHURST, MONMOUTH COUNTY, NEW JERSEY, AND PROVIDING PENALTIES AND IMPRISONMENT FOR THE VIOLATION THEREOF", ADOPTED JULY 20, 1970 AND AMENDED AND SUPPLEMENTED.

**BE IT ORDAINED** By the Board of Commissioners of the Borough of Allenhurst as follows:

## **SECTION I**

That the following be added as Section 4 of an Ordinance entitled, "AN ORDINANCE ENTITLED, "AN ORDINANCE REGULATING PARKING AND DESIGNATING ONE WAY STREETS IN THE BOROUGH OF ALLENHURST, MONMOUTH COUNTY, NEW JERSEY, AND PROVIDING PENALTIES AND IMPRISONMENT FOR THE VIOLATION THEREOF", adopted July, 1970:

Section 4. That restricted parking spaces for use by persons who have been issued

special vehicle identification cards by the NJ Division of Motor Vehicles pursuant to the provisions of N.J.S.A. 39:4-204, et seq., be designated in the Borough of Allenhurst as follows:

1. Such restricted space shall be adjacent to the southerly line of Corlies Avenue at the vehicle gate of the pool complex, beginning at a point 46 feet west of the easterly terminus of Corlies Avenue and extending in a northwesterly direction for a distance of 46 feet.

2. Such restricted space shall be located within the Allenhurst Borough Hall parking lot at 125 Corlies Avenue.

Any person parking a motor vehicle in a restricted parking space without a special vehicle identification card shall be liable to a fine of \$250.00 for the first offense and for subsequent offenses, a fine of at least \$250.00 and up to 90 days community service on such terms and in such form as the Court shall deem appropriate of any combination thereof.

Any vehicle parked in violation of N.J.S.A. 39:4-1380 shall be subject by removal by a law enforcement officer. It shall be the obligation of the owner of the motor vehicle to pay the reasonable costs for the removal and for any storage which may result from the removal.

## **SECTION II**

That the following be added as Section 5 of the above-entitled ordinance:

Section 5. That restricted parking spaces be designated for use of Municipal Officials and Allenhurst Fire Department and First Aid responders who have been issued identification cards for this purpose by the Allenhurst Police Department.

Space #1 - Adjacent to the norhterly line of Corlies Avenue, beginning at a point 41 feet west of the western line of Ocean Place and Corlies Avenue, extending in a westerly direction for a distance of 22 feet.

Space #2 - Adjacent to the southerly line of Corlies Avenue and the Allenhurst Beach club, beginning at a point 112 feet east of the easterly line of the intersection of Ocean Place and Corlies Avenue, extending in an easterly direction for a distance of 10 feet.

Any person parking a motor vehicle in a restricted parking space without a special vehicle identification card shall be liable to a fine of \$100.00 for the first offense and for subsequent offenses, a fine of at least \$100.00 and up to 90 days community service on such terms and in such form as the Court shall deem appropriate of any combination thereof.

Any vehicle parked in violation of this ordinance shall be subject by removal by a law enforcement officer. It shall be the obligation of the owner of the motor vehicle to pay the reasonable costs for the removal and for any storage which may result from the removal.

#### **SECTION III - GENERAL PROVISIONS**

If any section or provision hereof shall be adjudged invalid, such determination shall not affect the other provisions hereof which shall remain in full force and effect to the extent of such conflict or inconsistency provided not otherwise required by law.

# **SECTION IV - DATE OF EFFECT**

This Ordinance shall take effect twenty days after its final passage and publication in accordance with the law.
