I. Chapter III, Section 3-7.1 "Penalties" be and is hereby revised by deleting the existing section A3-7.1" and replacing it with the following:

WHEREAS, The Uniform Shared Services and Consolidation Act (C.40A:565-1, et seq.), authorizes local units of this State to enter into a contract with any other local unit(s) for the join provision within their several jurisdictions of any service, which any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, each municipality is to provide for the preparation of yearly revisions to the tax map under New Jersey State law N.J.A.C. 18:23A-1.1, and this legal requirement is not followed by all municipalities based on limited financial, technical and professional resources; and

WHEREAS, each physical description of a parcel of land drives the mass-appraisal calculation of the land portion of its property tax assessment, and land data inaccuracies and errors lead to poor distribution of the annual tax levy, potentially resulting in years of tax bill overpayments and underpayments; and

WHEREAS, a County-to-Municipality shared services program would provide map conversion and maintenance services, ushering in the transition from analog to a Countywide standard of state-certified digital tax maps for all 53 municipalities; and

WHEREAS, the intent of the digital tax map shared services program is to reduce municipal costs in complying with the law and provide for the most up-to-date GIS parcel layer and tax map data for public and government stakeholders; and

WHEREAS, this service provides participating municipalities with numerous benefits, including: anticipated cost-savings through economies-of-scale; reduce cost to comply with state regulations and standards; transition from analog to state-certified digital maps; streamlined editing and ongoing maintenance procedures; more consistent and accurate municipal and County-wide information; unprecedented assemblage of data made available to taxpayers, municipalities and the County; and seamless flow of tax information into GIS and additional information systems.

WHEREAS, it is in the best interest of THE BOROUGH OF ALLENHURST to enter into such an Agreement.

He needs to turn on the air and test other systems and close-up the house properly. Also, they would like to remove a dead tree and remove and replace dead grass. The Mayor advised that landscaping is allowed as long as there is no heavy machinery.

2. Chera, Richard – 1 Spier

9 days, 72 hours total

-Remove and Replacement of manufacturer defected door. The defected door allow water to infiltrate the interior of the home each time it rains. The stucco will need to be repaired once the door is replaced.

-Discussion:

Rob Adler, architect for project. Folding door systems on east face of house, 2nd flood system has failed completely and is also allowing water during rainfall comes into the house and pours into the home. A new door has finally been provided by the company to replace the defective door. They have attempted caulking and other temporary fixes and nothing has helped. There may be structural damage from decay resulting from the water which would also need to be addressed, as well as exterior stucco on the section in question.

Comm. McLoughlin asked what the harm would be in putting off stucco repair until after the moratorium. Mr. XXXX advised that they plan on multitasking portions as much as possible and would not save any time or noise. Comm. McLoughlin asked how many crew would be on site. Mr. XXX advised around 5 crew at any one time.

The Mayor asked how many days would be needed to replace the door. Mr. XX advised it would be 7 days, but unclear as they need to access the damage.

Daniellla Levy, neighbor, stated she came to meeting just to hear the scope of work and get details. She did not object but expressed concern about where sawing would take place.

Extension APPROVED five days of works. Commissioners advised they would allow 5 days, weekdays only. Contractor must email the Borough Administrator to advise what days they will be working, as days may not be consecutive. Contractors can only park as close at the 300 Block. And to try to do cutting in mornings and on the balcony and keep work on east side of house.
